

Carnival Holiday Season Sweepstakes

Official Rules

No Purchase Necessary to Enter or Win. A Purchase will Not Increase Your Chances of Winning.

Eligibility: The Carnival Holiday Season Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of the 50 United States (and the District of Columbia) who are at least twenty-one (21) years of age at the time/date of entry (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of New York Jets LLC ("Sponsor"), Carnival Cruise Line, the NFL Entities (defined below), teamDigital Promotions, Inc. You may only use one (1) email address to enter the Sweepstakes. Entries received from any person, email address, or household in excess of the above stated limitation will be void.** Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, address and other information for the purpose of administering this Sweepstakes.
