

## 2025 Green and White Day Rewards Giveaway

### Official Rules

**No Purchase or Use of Points Necessary to Enter or Win. Making a Purchase or Using Your Points Will Not Improve Your Chances of Winning.**

**Eligibility:** The 2025 Green and White Day Rewards Giveaway (hereafter, "Sweepstakes") is open to legal residents of New York, New Jersey, Pennsylvania and Connecticut who are at least eighteen (18) years of age at the time of entry (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of New York Jets LLC ("Sponsor"), New Meadowlands Stadium Company LLC (dba MetLife Stadium), Jets Stadium Development LLC, the NFL Entities (defined below), Paramount+, teamDigital Promotions, Inc.
