

## Jets Fan Cruise Sweepstakes Presented by SeaSide Events Official Rules

**No Purchase Necessary to Enter or Win. A Purchase will Not Increase Your Chances of Winning.**

**Grand Prize winner must be willing and available to travel on the 2026 Jets Fan Cruise sailing July 9-14, 2026 or otherwise forfeit his/her right to receive the Grand Prize.**

**Eligibility:** The Jets Fan Cruise Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of the 50 United States (and the District of Columbia) who are at least twenty-one (21) years of age at the time/date of entry (hereafter, "Eligible Entrants").
