

New York Jets & NJ Lottery Sweepstakes Official Rules

No Purchase Necessary to Enter or Win. A Purchase will Not Increase Your Chances of Winning. This Sweepstakes, including any entry method or prize offered, may be cancelled or postponed by Sponsor, in full or in part, at any time, due to reasons related to the ongoing pandemic (e.g., Coronavirus/Covid-19).

Eligibility: The New York Jets & NJ Lottery Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of New York, New Jersey and Connecticut who are at least eighteen (18) years old at the time of entry. Employees, officers, directors, agents and representatives of New York Jets LLC ("Sponsor"), New Jersey Lottery, Northstar New Jersey Lottery Group, LLC, the National Football League, its member professional football clubs, NFL Ventures, L.P., teamDigital Promotions, Inc. ("teamDigital"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. How to Enter: Visit nyjets.com/njlottery during the Promotion Period and follow the instructions provided to complete/submit the Official Entry Form to receive one (1) entry. All entries must be received by 11:59:59 pm ET on 10/27/22 to be eligible. **Limit one (1) entry per person, per email address and per household throughout the Promotion Period. You may only use one (1) email address to enter the Sweepstakes. Entries received from any person, email address, or household in excess of the above stated limitation will be void.** Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, address and other information for the purpose of administering this Sweepstakes. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) will be void. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, damaged, inaccurate, or undelivered entries; or for telephonic, human or computer failures, problems or errors, defects or delays in any transmission, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by

equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prize, for any injury or damage to participant's or any other person's computer or other device relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants and disqualify such entrants whom Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes and/or who are in violation of these Official Rules.

Odds of winning will depend upon the total number of eligible entries received. Potential winners will be notified by telephone and/or email.

In addition, each Grand Prize winner will have the opportunity to be on field during the Ring of Honor ceremony for Jets Legend D'Brickashaw Ferguson and receive \$50 worth of Power 50x New Jersey Lottery scratch-off tickets. Approximate Retail Value ("ARV") of each Grand Prize: \$500. Three (3) First Prizes: Each First Prize winner will receive two (2) tickets, and one (1) parking pass, to the New York Jets home game currently scheduled for 10/30/22. In addition, each First Prize winner will have the opportunity to participate in the endzone experience pregame, watch the player tunnel run out, national anthem and coin toss from the field and receive \$50 worth of Power 50x New Jersey Lottery scratch-off tickets. ARV of each First Prize: \$500. **TRANSPORTATION TO/FROM THE GAME IS NOT PROVIDED AS PART OF THIS PRIZE. DO NOT PARTICIPATE IN THIS PROMOTION IF YOU ARE NOT PREPARED TO PAY FOR TRANSPORTATION TO/FROM THE GAME.** In the event the game is postponed and rescheduled, game tickets and parking pass will be reissued. If the game is postponed and not rescheduled, Sponsor will provide an alternate prize of equal or greater value. Exact seat location at the game, and location of parking spot, and other details will be determined by the Sponsor in its sole discretion. Winner and guest must comply with all venue rules and regulations. Failure to do so may result in forfeiture of such portion of the prize and removal from the game. Released Parties reserve the right to remove or to deny attendance to any winner and his/her guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the game. Game tickets are subject to the terms and conditions specified thereon. If unused, tickets cannot be returned, refunded or exchanged for cash value or substitute tickets. All prize details are at Sponsor's sole discretion. Prize is awarded "as is" without any warranty or guarantee, either express or implied by Sponsor. All federal, state and local taxes, and any costs and expenses associated with the acceptance and use of prize not specified herein as being awarded is winner's sole responsibility. Total ARV of all prizes: \$3,500.

Miscellaneous: No transfer, assignment, cash redemption, or substitution of prize is permitted except by Sponsor who reserves the right to substitute a prize with one of comparable or greater value, at its sole discretion. to the prize notification by the applicable response deadline, Sponsor shall have no further obligation to that potential winner and an alternate winner may be randomly selected (time permitting) from among all remaining eligible entries. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with participating in this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.
