

Jet Away with JetBlue Sweepstakes Official Rules

No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.

Eligibility: The Jet Away with JetBlue Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of the fifty (50) U.S. (including D.C.) who have reached the legal age of majority (which is 18 in most states, but 19 in Alabama and Nebraska and 21 in Mississippi) in their state of residence (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of New York Jets LLC ("Sponsor"), JetBlue Airways Corporation, the NFL Entities (defined below), teamDigital Promotions, Inc. ("teamDigital"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Promotion Period: Sweepstakes begins 12:00:00 am Eastern Time ("ET") on 5/18/26 and ends 11:59:59 pm ET on 6/7/26 (hereafter, "Promotion Period").

1) Opt-in To Receive Text Messages: Eligible Entrants must first text the keyword "JETBLUE" to 26154 from their mobile device. By responding "Y" to the automated text message, Eligible Entrant will receive one (1) entry. Eligible Entrant will be charged standard messaging and/or data rates for each text message sent from and received by their device according to the terms of their wireless service agreement. Eligible Entrant must be a wireless service subscriber with text messaging functionality to enter via this method. Eligible Entrant should check their phone capabilities for specific text messaging instructions. Text messaging is not available in all areas.

2) Online Entry Form: Visit nyjets.com/jetaway during the Promotion Period and follow the instructions provided to complete/submit the Official Entry Form to receive one (1) entry.

All entries must be received by 11:59:59 pm ET on 6/7/26 to be eligible. Limit one (1) entry per person, per email address and per household throughout the Promotion Period. You may only use one (1) email address to enter the Sweepstakes. Entries received from any person, email address, or household in excess of the above stated limitation will be void. Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, email address, address and other information for the purpose of administering this Sweepstakes. 2/9/26 (SFO only), 2/12/26-2/23/26 (all destinations), 2/26/26-4/12/26 (all destinations), 4/16/26-4/27/26 (BDL, BOS, MHT, ORH, PVD only), 5/22/26-5/25/26 (all destinations), 6/26/26-7/6/26 (all destinations), 9/4/26-9/7/26 (all destinations), 10/9/26-10/12/26 (all destinations), 11/20/26-11/30/26 (all destinations) and 12/18/26-1/4/27 (all destinations).
