Jets VIP Draft Party Sweepstakes Official Rules

No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.

Eligibility: The Jets VIP Draft Party Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of New York, New Jersey, Pennsylvania, and Connecticut who are at least eighteen (18) years of age at the time of entry (hereafter, "Eligible Entrants").
