

Jets VIP Draft Party Sweepstakes Official Rules

No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.

Eligibility: The Jets VIP Draft Party Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of New York, New Jersey, Pennsylvania, and Connecticut who are at least eighteen (18) years of age at the time of entry (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of New York Jets LLC ("Sponsor"), Verizon, Dunkin' Brands, Inc., PepsiCo, Daily News Enterprises, the National Football League, its member professional football clubs, NFL Ventures, L.P., teamDigital Promotions, Inc. ("teamDigital"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Promotion Period: Sweepstakes begins 12:00:00 am Eastern Time ("ET") on 4/3/24 and ends 11:59:59 pm ET on 4/14/24 (hereafter, "Promotion Period").

How to Enter: During the Promotion Period, Eligible Entrants will have the opportunity to enter the Sweepstakes via one (1) of the following two (2) ways:

1) Opt-in To Receive Text Messages: Eligible Entrants must first text the keyword "DRAFTPARTY" to 26154 from their mobile device. Upon completion, Eligible Entrant will receive an automated text message from the New York Jets confirming their desire to opt-in to receive recurring future automated text messages. By responding "Y" to the automated text message, Eligible Entrant will be opted in to receive such text messages to the mobile number from which they texted and receive one (1) entry. Consent is not required to purchase or to enter, text STOP to opt-out and HELP for more information. Eligible Entrant will be charged standard messaging and/or data rates for each text message sent from and received by their device according to the terms of their wireless service agreement. Eligible Entrant must be a wireless service subscriber with text messaging functionality to enter via this method. Eligible Entrant should check their phone capabilities for specific text messaging instructions. Text messaging is not available in all areas.

2) Online Entry Form: To enter without opting in to receive recurring automated text

messages from the New York Jets, visit nyjets.com/draftpartysweeps during the Promotion Period and follow the instructions provided to complete/submit the Official Entry Form to receive one (1) entry.

All entries must be received by 11:59:59 pm ET on 4/14/24 to be eligible. Limit one (1) entry per person, per email address and per household throughout the Promotion Period. You may only use one (1) email address or mobile phone number to enter the Sweepstakes. Entries received from any person, email address, or household in excess of the above stated limitation will be void. Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, email address, mobile phone number, address and other information for the purpose of administering this Sweepstakes and as otherwise set forth in Sponsor's Privacy Policy. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) will be void. In the event of a dispute as to the identity of an entrant based on the email address submitted, entry will be awarded to the person named on the applicable Official Entry Form (regardless of whether that is the name of the authorized account holder of the email address from which said entry form was submitted) provided such individual is eligible according to these Official Rules.

Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, damaged, inaccurate, or undelivered entries, emails, or other communications of any kind; or for telephonic, human or computer failures, problems or errors, defects or delays in any transmission, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prize, for any injury or damage to participant's or any other person's computer or other device relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants and disqualify such entrants whom Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes and/or who are in violation of these Official Rules.

Winner Selection & Notification: One (1) potential Grand Prize winner will be randomly selected on or about 4/15/24 from among all eligible entries received. Odds of winning will depend upon the total number of eligible entries received. Potential Grand Prize winner will be notified by their mobile telephone number and/or email, depending on entry method. Potential winner will be required to execute and return an Affidavit of Eligibility, Liability and (where legal) Publicity Release as well as any other documents required by Sponsor within two (2) days of date of issuance of notification. Winner's guest (or the parent/legal guardian of a minor guest) must execute and return a Liability/Publicity Release prior to Event (defined below). Noncompliance with any of the foregoing, failure to respond within the designated timeframe, the inability to contact the potential winner within a reasonable time period, or any notification being returned as undeliverable or potential winner's noncompliance with these rules may result in disqualification and, at Sponsor's discretion and time permitting, an alternate winner being selected. The Released Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in the potential winner's email account to receive email messages.

One (1) Grand Prize: VIP admission for winner and one (1) guest to attend the New York Jets Draft Party at MetLife Stadium on April 25, 2024 (hereafter "Event"). Event consists of exclusive access to watch the first round of the NFL Draft live from a premium area in MetLife Stadium, food and non-alcoholic beverages. Due to the unique nature of the prize no retail value could be determined. All Event details to be determined by Sponsor in its sole discretion. If winner is not able to attend the Event on the designated date, prize will be forfeited in its entirety and may be awarded to an alternate winner, in Sponsor's sole discretion, time permitting.
