

NY Jets Ticket Sell-Back Credit Program – Exclusive Multi-Seat Season Ticket Holder Benefit!

Starting this 2024-25 NFL season, multi-seat season ticket holders have the flexibility to exchange tickets for games they cannot attend for a credit toward the 2025-26 season through the NEW NY Jets Ticket Sell-Back Credit Program!

Here are the terms for the NY Jets Ticket Sell-Back Credit Program (the “Credit Program”):

- I. For each individual season ticket account, tickets for up to three (3) regular season home games of the current (2024-25) season can be exchanged in the Credit Program. Preseason and post-season game(s) are not eligible.
- II. The Credit Program will run from May 29, 2024 to July 31, 2024 (the “Credit Window”). For any tickets turned back in during this time, a credit will be applied to the individual season ticket holder’s account, which will be applied towards their 2025-26 season ticket renewal fee (the “Credit”). The amount of each Credit will be based on the variable pricing schedule announced upon the 2024-25 NFL season schedule release.
- III. The Credit Program process will occur fully online. Ticket exchanges and Ticket Credits will only be available through Jets Account Manager (it will not be available on the Jets’ mobile app). Further instruction will be communicated prior to the commencement of the Credit Window.
- IV. Any tickets returned to the Jets through the Credit Program cannot later be sold back to the season ticket holder.
- V. The Credit MUST be used for subsequent 2025-26 NFL season ticket renewals and cannot be transferred or used for any other purchases. This is a ticket credit only and does not entitle the season ticket holder to a cash refund. *Furthermore, the Credit cannot be rolled over for any future seasons. If you do not renew for the 2025-2026 NFL season, the Credit will expire and not be made available for future seasons.*
- VI. Only tickets for adjacent seats are eligible for the Credit Program. Partial ticket exchanges will be considered under certain conditions (i.e., exchanging only two (2) of four (4) seats), however, a partial ticket exchange will still count as 1 of the 3 games eligible to be exchanged for Credit. Single seats are not eligible for Credits; this offer is only available for 2 or more adjacent tickets.
- VII. Accounts are not able to move or change their season ticket locations for the 2024-25 season once seats are exchanged through the Credit Program.
- VIII. Parking passes are not eligible to be returned through the Credit Program.
- IX. For season ticket holders to be eligible for the Credit Program, the following terms apply:
 - a. Only multi-seat accounts are eligible.
 - b. Accounts must be paid in full and/or the selected game(s) must be fully paid to participate.

- c. Any tickets transferred, posted for re-sale, or donated to a third-party are not eligible for exchange through the Credit Program.

Each game credit value will follow the variable pricing schedule and will be announced upon the 2024-25 NFL season schedule release.
