

NY Jets Ticket Sell-Back Credit Program - Exclusive Multi-Seat Season Ticket Member Benefit! For the 2026-27 season, the NY Jets will again offer multi-seat season ticket holders the flexibility to exchange tickets and parking passes for games they cannot attend for a credit toward the 2027-28 season through the Ticket Sell-Back Credit Program ("Credit Program")! Here are the terms for the NY Jets Ticket Sell-Back Credit Program: I. Up to three (3) regular season home games of the current (2026-27) season can be included in the Credit Program, per season ticket account. Preseason and post-season game(s) are not eligible. Parking passes are eligible for the Credit Program only for games for which tickets are also exchanged in the Credit Program. II. The Credit Program will run from June 23, 2026, to August 1, 2026 (the "Credit Window"). For any eligible games turned back in during the Credit Window, a credit will be added to the individual season ticket member's account, which will be applied towards their 2027- 28 season ticket renewal fee (the "Credit"). The amount of the Credit for each ticket or parking pass will correspond to the amount paid for that ticket or parking pass as reflected on the account holder's season ticket invoice for the 2026-27 NFL season. III. The Credit Program process will occur fully online. Ticket Credits will only be available through Jets Account Manager (not on the Jets' mobile app). Further instruction will be communicated prior to the commencement of the Credit Window. IV. Any tickets and parking passes returned to the Jets through the Credit Program cannot later be sold back to the season ticket member. V. The Credit MUST be used ONLY for the 2027-28 NFL season ticket renewal and cannot be transferred or used for any other purchases. This credit does not entitle the season ticket member to a cash refund and cannot be rolled over for future seasons. If the account does not renew for the 2027-28 season, the Credit will expire. VI. Seats must be adjacent to be eligible for the Credit Program. Partial exchanges may be permitted under certain conditions but will still count as one of the three (3) eligible games. Single seat credits are not eligible. VII. Accounts may not change season ticket locations for the 2026-27 season after participating in the Credit Program. VIII. Eligibility requirements: - Only multi-seat accounts are eligible - Accounts must be fully paid (or games must be fully paid) to participate - Tickets or parking passes that have been transferred, resold, or donated are not eligible - Each game credit value will follow the variable ticket pricing schedule. - Beginning with the Credit Program for the exchange of 2027-28 season tickets, a condition of eligibility will be the account holder's attendance at a minimum of (3) Jets regular season home games during the immediately preceding season. (In other words, if the account holder does not attend at least three (3) Jets regular season home games during the 2026- 27 season, the account will not be eligible to exchange tickets during the 2027-28 season.) In that case, your credit from the prior season (if any) will still apply to your season ticket invoice for the then-current season, but you will not be eligible to exchange tickets during the then-current season. Whether an account holder attended a game will be determined by the Jets in their

sole discretion, by matching the email address associated with the season ticket account with the email address of the ticket holder who scans the ticket to attend the applicable game(s). For example, if an account holder transfers all of his or her tickets for a game to someone else and then attends the game with that other person, for purposes of this condition, the account holder will be deemed as not having attended that game unless at least one of those tickets is transferred back to the account holder's email address prior to scanning at the Stadium without further transfer to a different email address.

These terms and conditions are applicable to the Credit Program for the current NFL season. The Jets reserve the right to modify the Credit Program with respect to any future NFL season, which may include not continuing the Credit Program in with respect to any future NFL season.
