Jets Dunkin' Holiday Sweepstakes Official Rules

No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.

This Sweepstakes, including any entry method or prize offered, may be cancelled or postponed by Sponsor, in full or in part, at any time, due to reasons related to the ongoing pandemic (e.g., Coronavirus/Covid-19).

Eligibility: The Jets Dunkin' Holiday Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of New York, New Jersey and Connecticut who are at least eighteen (18) years old at the time of entry (hereafter, "Eligible Entrants"). <u>2) Online Entry Form:</u> Visit nyjets.com/Dunkin during the Promotion Period and follow the instructions provided to complete/submit the Official Entry Form to receive one (1) entry.

3) Mail: To receive one (1) entry by mail, Eligible Entrants can hand print their name, complete mailing address, telephone number, date of birth, and the words "Jets Dunkin' Holiday Sweepstakes" on a plain 3" x 5" piece of paper and mail it in a <u>sealed</u>, stamped and hand printed #10 envelope to be received by 1/9/23 to: Jets Dunkin' Holiday Sweepstakes Entry, 1 Jets Drive, Florham Park, NJ 07932.

Limit one (1) entry per person, per email address and per household throughout the Promotion Period. You may only use one (1) email address to enter the Sweepstakes. Entries received from any person, email address, or household in excess of the above stated limitation will be void. Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, address and other information for the purpose of administering this Sweepstakes.
