

## Jets/Dunkin' Draft Experience Sweepstakes Official Rules

**No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.**

**This Sweepstakes, including any entry method or prize offered, may be cancelled or postponed by Sponsor, in full or in part, at any time, due to reasons related to the ongoing pandemic (e.g., Coronavirus/Covid-19).**

**Eligibility:** The Jets/Dunkin' Draft Experience Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of New York, New Jersey, Pennsylvania, and Connecticut that reside within a 75-mile radius of MetLife Stadium (in East Rutherford, NJ) who are at least twenty-one (21) years old at the time of entry (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of New York Jets LLC ("Sponsor"), Dunkin' Brands, Inc., the National Football League, its member professional football clubs, NFL Ventures, L.P., teamDigital Promotions, Inc. ("teamDigital"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside NY, NJ, PA, CT and where prohibited by law. All applicable federal, state and local laws apply.

**Promotion Period:** Sweepstakes begins 12:00:00 am Eastern Time ("ET") on 3/2/23 and ends 11:59:59 pm ET on 3/24/23 (hereafter, "Promotion Period").

**How to Enter:** During the Promotion Period, Eligible Entrants will have the opportunity to enter the Sweepstakes via one (1) of the following two (2) ways:

1) Opt-in To Receive Text Messages: Eligible Entrants must first text the keyword "Dunkin" to 26154 from their mobile device. Upon completion, Eligible Entrant will receive an automated text message from the New York Jets confirming their desire to opt-in to receive future text messages. By responding "Y" to the automated text message, Eligible Entrant will receive one (1) entry. Eligible Entrant will be charged standard messaging and/or data rates for each text message sent from and received by their device according to the terms of their wireless service agreement. Eligible Entrant must be a wireless service subscriber with text messaging functionality to enter via this method. Eligible Entrant should check their phone capabilities for specific text messaging instructions. Text messaging is not available in all areas.

2) Online Entry Form: Visit [nyjets.com/Dunkin](https://nyjets.com/Dunkin) during the Promotion Period and follow

the instructions provided to complete/submit the Official Entry Form to receive one (1) entry.

**All entries must be received by 11:59:59 pm ET on 3/24/23 to be eligible. Limit one (1) entry per person, per email address and per household throughout the Promotion Period. You may only use one (1) email address to enter the Sweepstakes. Entries received from any person, email address, or household in excess of the above stated limitation will be void.** Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, email address, address and other information for the purpose of administering this Sweepstakes. Odds of winning will depend upon the total number of eligible entries received. Potential Grand Prize winner will be notified by telephone and/or email. Potential winner will be required to execute and return an Affidavit of Eligibility, Liability and (where legal) Publicity Release as well as any other documents required by Sponsor within two (2) days of date of issuance of notification. Winner's guest must be at least twenty-one (21) years of age and must execute and return a Liability/Publicity Release prior to travel.
