

Jets/Dunkin' Trip to Draft Sweepstakes Official Rules

No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.

1) Eligibility: The Jets/Dunkin' Trip to Draft Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of the fifty (50) United States (including the District of Columbia) who have reached the legal age of majority (which is 18 in most states, but 19 in Alabama and Nebraska and 21 in Mississippi) at the time of entry in their state of residence (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of New York Jets LLC ("Sponsor"), Dunkin' Brands, Inc., the National Football League, its member professional football clubs, NFL Entities, teamDigital Promotions, Inc. ("teamDigital"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively with Dunkin Brands, Inc., "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void where prohibited by law. All applicable federal, state and local laws apply.

2) Promotion Period: Sweepstakes begins 12:00:00 am Eastern Time ("ET") on 3/16/26 and ends 11:59:59 pm ET on 4/5/26 (hereafter, "Promotion Period").

3) How to Enter: During the Promotion Period, Eligible Entrants will have the opportunity to enter the Sweepstakes via one (1) of the following two (2) ways:

1) Opt-in To Receive Text Messages: Eligible Entrants must first text the keyword "DRAFTTRIP" to 26154 from their mobile device. Upon completion, Eligible Entrant will receive an automated text message from the New York Jets confirming their desire to opt-in to receive recurring future automated text messages. By responding "Y" to the automated text message, Eligible Entrant will be opted in to receive such text messages to the mobile number from which they texted and receive one (1) entry. Consent is not require to purchase or to enter, text STOP to opt-out and HELP for more information. Eligible Entrant will be charged standard messaging and/or data rates for each text message sent from and received by their device according to the terms of their wireless service agreement. Eligible Entrant must be a wireless service subscriber with text messaging functionality to enter via this method. Eligible Entrant should check their phone capabilities for specific text messaging instructions. Text messaging is not available in all areas.

2) Online Entry Form: To enter without opting in to receive recurring automated text messages from the New York Jets, visit nyjets.com/triptodraft during the Promotion Period and follow the instructions provided to complete/submit the Official Entry Form to receive one (1) entry.

All entries must be received by 11:59:59 pm ET on 4/5/26 to be eligible. Limit one (1) entry per person, per email address and per household throughout the Promotion Period. You may only use one (1) email address or mobile phone number to enter the Sweepstakes. Entries received from any person, email address, or household in excess of the above stated limitation will be void. Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, email address, mobile phone number, address and other information for the purpose of administering this Sweepstakes and as otherwise set forth in Sponsor's Privacy Policy. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) will be void. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. In the event of a dispute as to the identity of an entrant who is opting-in to receive text messages, entry will be awarded to the person named as the primary account holder of the cell phone used to opt-in, provided such individual is eligible according to these Official Rules. In the event of a dispute as to the identity of an entrant based on the email address submitted, entry will be awarded to the person named on the applicable Official Entry Form (regardless of whether that is the name of the authorized account holder of the email address from which said entry form was submitted) provided such individual is eligible according to these Official Rules.

Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, damaged, inaccurate, or undelivered entries, emails, or other communications of any kind; or for telephonic, human or computer failures, problems or errors, defects or delays in any transmission, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prize, for any injury or damage to participant's or any other person's computer or other device relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants and disqualify such entrants whom Sponsor believes have attempted to tamper with or

impair the administration, security, fairness or proper play of this Sweepstakes and/or who are in violation of these Official Rules.

4) Winner Selection & Notification: One (1) potential Grand Prize winner will be randomly selected on or about 4/6/26 from among all eligible entries received. Each valid entry, regardless of method of entry, will have an equal chance of winning. Odds of winning will depend upon the total number of eligible entries received. Potential Grand Prize winner will be notified by their mobile telephone number and/or email, depending on entry method. Potential winner will be required to execute and return an Affidavit of Eligibility, Liability and (where legal) Publicity Release as well as any other documents required by Sponsor within two (2) days of date of issuance of notification. Winner's guest must be at least eighteen (18) years of age and must execute and return a Liability/Publicity Release prior to travel. Potential winner must also supply Sponsor with a complete and valid IRS Form W-9 prior to receiving the applicable prize. The value of a prize is taxable to winner as income. An IRS Form 1099 will be issued in the name of the applicable winner for the actual value of the prize awarded. Noncompliance with any of the foregoing, failure to respond within the designated timeframe, the inability to contact the potential winner within a reasonable time period, or any notification being returned as undeliverable or potential winner's noncompliance with these rules may result in disqualification and, at Sponsor's discretion and time permitting, an alternate winner being selected. Winner status is subject to verification of eligibility and compliance with these Official Rules. The Released Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in the potential winner's email account to receive email messages.

5) One (1) Grand Prize: Grand Prize includes a 3-night trip for winner and one (1) guest to attend the first round of the 2026 NFL Draft currently scheduled to be held in Pittsburgh, PA on April 23, 2026 (hereafter "Trip") and Dunkin' coffee for a year (for winner only) awarded in the form of a \$598 Dunkin' gift card. Trip consists of round-trip coach air transportation from major airport closest to winner's primary residence to Pittsburgh, PA, standard double-occupancy hotel accommodations (one room) for three (3) nights in Pittsburgh, PA, two (2) tickets to attend the first round of the 2026 NFL Draft on April 23, 2026, and ground transportation to/from airport/hotel (while in Pittsburgh, PA). If the first round of the 2026 NFL Draft is canceled or postponed for any reason, terms of the tickets shall govern, including any raincheck policies and no compensation or substitution will be provided; however, remainder of Trip will be awarded and Sponsor will have no further obligation to winner. Unless otherwise indicated herein, all expenses and travel costs including, but not limited to, all transportation, parking, meals, incidental, surcharges, service charge or facility charges, personal charges at hotel, taxes or other expense, of the Grand Prize are the responsibility of winner and their guest. All elements of the Grand Prize are subject to availability, blackout days and other restrictions. The Grand Prize winner will be required to present a major valid credit card at the time of check-in to cover incidentals and fees/services not included in the prize. Actual value of prize may vary based on time of stay, flights and other factors. No changes may be made by Grand Prize winner (or winner's guest) to prize details once any portion of arrangements has been made. By participating, Eligible Entrants agree to be bound by these Official Rules and agree that: 1) Sponsor and its designees may use (unless prohibited by law) entrant's name, city and state of residence, photograph, any oral or written statements, and/or likeness for advertising, trade and/or any other purposes in any media now or hereafter known throughout the world in perpetuity, without further compensation, permission or notification, and 2) the Released Parties shall have no liability and entrant will defend, indemnify and hold harmless Sponsor and the Released Parties from and against any claim, action, liability, loss, injury or damage to entrant or any other person or entity, including, without limitation, personal injury or death to entrant or any other person or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of the prize (including, but not limited to, and travel or activity related thereto) or participation in this Sweepstakes.
