

Your Ticket to Sail with Carnival Sweepstakes

Official Rules

No Purchase Necessary to Enter or Win. A Purchase will Not Increase Your Chances of Winning.

Eligibility: The Your Ticket to Sail with Carnival Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of the 50 United States (and the District of Columbia) who are at least twenty-one (21) years of age at the time/date of entry (hereafter, "Eligible Entrants").
