Draft Day Giveaway Sweepstakes Official Rules

No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.

Eligibility: The Draft Day Giveaway Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of the fifty (50) United States (including the District of Columbia) who have reached the legal age of majority (which is 18 in most states, but 19 in Alabama and Nebraska and 21 in Mississippi) in their state of residence (hereafter, "Eligible Entrants").
