

New York Jets & New Jersey Lottery Fall Sweepstakes Official Rules

No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.

Eligibility: The New York Jets & New Jersey Lottery Fall Sweepstakes (hereafter, “Sweepstakes”) is open to legal residents of New York, New Jersey, Pennsylvania and Connecticut who are at least eighteen (18) years old at the time of entry. Employees, officers, directors, agents and representatives of New York Jets LLC (“Sponsor”), New Meadowlands Stadium Company LLC (dba MetLife Stadium), Jets Stadium Development LLC, New Jersey Lottery, Northstar New Jersey Lottery Group, LLC, the National Football League, its member professional football clubs, NFL Ventures, L.P., teamDigital Promotions, Inc. (“teamDigital”), and each of their respective parents, affiliates, subsidiaries, members, wholesalers, contractors, subcontractors, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, “Released Parties”), and each such individual’s immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside NY, NJ, PA, CT and where prohibited by law. All applicable federal, state and local laws apply.

Promotion Period: Sweepstakes begins 12:00:00 am Eastern Time (“ET”) on 10/8/25 and ends 11:59:59 pm ET on 10/26/25 (hereafter, “Promotion Period”).

How to Enter: During the Promotion Period, Eligible Entrants will have the opportunity to enter the Sweepstakes via one (1) of the following two (2) ways:

1) Opt-in To Receive Text Messages: Eligible Entrants must first text the keyword “FALL” to 26154 from their mobile device. Upon completion, Eligible Entrant will receive an automated text message from the New York Jets confirming their desire to opt-in to receive future text messages. By responding “Y” to the automated text message, Eligible Entrant will receive one (1) entry. Eligible Entrant will be charged standard messaging and/or data rates for each text message sent from and received by their device according to the terms of their wireless service agreement. Eligible Entrant must be a wireless service subscriber with text messaging functionality to enter via this method. Eligible Entrant should check their phone capabilities for specific text messaging instructions. Text messaging is not available in all areas.

2) Online Entry Form: Visit nyjets.com/fallsweeps during the Promotion Period and follow the instructions provided to complete/submit the Official Entry Form to receive one (1) entry.

All entries must be received by 11:59:59 pm ET on 10/26/25 to be eligible. Limit one (1) entry per person, per email address, per mobile device number and per household throughout the Promotion Period. You may only use one (1) email address or one (1) mobile device number to enter the Sweepstakes. Entries received from any person, email address, mobile device number or household

in excess of the above stated limitation will be void. Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, email address, address and other information for the purpose of administering this Sweepstakes. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) will be void. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. In the event of a dispute as to the identity of an entrant who is opting-in to receive text messages, entry will be awarded to the person named as the primary account holder of the cell phone used to opt-in, provided such individual is eligible according to these Official Rules. In the event of a dispute as to the identity of an entrant based on the email address submitted, entry will be awarded to the person named on the applicable Official Entry Form (regardless of whether that is the name of the authorized account holder of the email address from which said entry form was submitted) provided such individual is eligible according to these Official Rules.

Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, damaged, inaccurate, or undelivered entries, emails, text messages, or other communications of any kind; or for telephonic, human or computer failures, problems or errors, defects or delays in any transmission, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prize, for any injury or damage to participant's or any other person's computer or other device relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants and disqualify such entrants whom Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes and/or who are in violation of these Official Rules.

Winner Selection & Notification: One (1) potential winner will be randomly selected on or about 10/27/25 from among all eligible entries received. Odds of winning will depend upon the total number of eligible entries received. Potential winner will be notified by telephone, text message and/or email. Potential winner will be required to confirm eligibility and execute and return any required documents required by Sponsor within two (2) days of date of issuance of notification. Noncompliance with any of the foregoing, failure to respond within the designated timeframe, the inability to contact the potential winner within a reasonable time period, or any notification being returned as undeliverable may result in disqualification and, at Sponsor's discretion and time permitting, an alternate winner being selected. Winner status is subject to verification of eligibility and compliance with these Official Rules. The Released Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in the potential winner's email account to receive email messages.

One (1) Prize: Prize winner will receive four (4) Endzone tickets, and one (1) parking pass, to attend the New York Jets vs Atlanta Falcons football game currently scheduled to take place on 11/30/25 at MetLife Stadium. Winner and his/her guests agree to comply with all game and venue rules and regulations and, in accordance therewith, agree not to act in an unsportsmanlike or disruptive manner, or with any intent to annoy, abuse, threaten or harass any other person at the game. Failure to comply may result in forfeiture of such portion of the prize and removal from game. Winner and his/her guests will be escorted out of venue by Sponsor or its designated agent(s) for improper conduct and/or violation of federal, state or local laws (including, but not limited to, the unlawful possession, use, or distribution of illicit drugs, unlawful drug paraphernalia, and alcohol), as Sponsor determines in its sole discretion, and will forfeit the balance of prize. Unused tickets cannot be refunded, exchanged or applied towards tickets for any subsequent game.

Miscellaneous: No transfer, assignment, cash redemption, or substitution of prize is permitted except by Sponsor, who reserves the right to substitute the prize with one of comparable or greater value, at its sole discretion and except as otherwise provided herein.
