New York Jets & New Jersey Lottery Fall Sweepstakes Official Rules

No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.

Eligibility: The New York Jets & New Jersey Lottery Fall Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of New York, New Jersey, Pennsylvania and Connecticut who are at least eighteen (18) years old at the time of entry. Limit one (1) entry per person, per email address, per mobile device number and per household throughout the Promotion Period. in excess of the above stated limitation will be void.
