2024 Green and White Day Giveaway Official Rules

Official Rules

No Purchase Necessary to Enter or Win. A Purchase will Not Increase Your Chances of Winning.

Eligibility: The 2024 Green and White Day Giveaway (hereafter, "Sweepstakes") is open to legal residents of the fifty (50) U.S. (including D.C.) who are eighteen (18) years of age or older as of date of entry.
