Jets Season Ticket NFL Draft Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

1) Eligibility: The Jets Season Ticket NFL Draft Sweepstakes (hereafter, "Promotion") is open to legal permanent residents of New York, New Jersey, Pennsylvania, and Connecticut who are eighteen (18) years of age or older (hereafter, "Eligible Entrants"). 2) Promotion Period: Promotion starts 12:00:00 am Eastern Time ("ET") on 2/16/25 and ends at 11:59:59 pm ET on 4/1/25 (hereafter, "Promotion Period").

3) How to Enter: During the Promotion Period, Eligible Entrants will have the opportunity to enter the Promotion two (2) ways:

1) <u>Purchase of a new 2025 New York Jets Season Ticket</u>: Eligible Entrants will automatically receive one (1) entry when they make an Eligible Purchase of a season ticket for the New York Jets 2025 season. An "Eligible Purchase" is defined as an Eligible Entrant's purchase, during the Promotion Period, of a New York Jets season ticket subscription for a seat location at MetLife Stadium that such Eligible Entrant did not own by during the 2024 New York Jets season, towards which the Eligible Entrant pays, at the time/date of purchase, a minimum of \$200. One (1) entry will be earned for each season ticket subscription in an Eligible Purchase made during the Promotion Period, up to a maximum of four (4) entries per Eligible Entrant. By way of example, if an Eligible Entrant makes an Eligible Purchase consisting of a season ticket subscription for two (2) seat locations, such Eligible Entrant would earn two (2) entries, whereas an Eligible Entrant who makes an Eligible Purchase consisting of a season ticket subscription for four (4) or more seat locations would earn four (4) entries.

<u>Alternate Entry</u>: To receive one (1) entry without making a purchase, Eligible Entrants can hand print their name, complete mailing address, telephone number, email, date of

birth, and the words "Season Ticket NFL Draft" on a plain 3" x 5" piece of paper and mail it in a sealed, stamped and hand printed #10 envelope to: Jets Season Ticket NFL Draft Sweepstakes, 1 Jets Drive, Florham Park, NJ 07932. Enter as often as you wish by mail, but each entry must be postmarked by 4/2/25 and received by 4/7/25.

Entries must be received by applicable dates specified above to be eligible for the Promotion. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Promotion is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) are void.
