

New York Jets Suites Sweepstakes Official Rules

No Purchase Necessary to Enter or Win. A Purchase Will Not Increase Your Chances of Winning.

Eligibility: The New York Jets Suites Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of New York, New Jersey, Pennsylvania, and Connecticut who are at least twenty-one (21) years of age at time/date of entry (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of New York Jets LLC ("Sponsor"), the NFL Entities (as described below), teamDigital Promotions, Inc. Consumers who complete and submit the Lead Gen Form during the Promotion Period will receive one (1) entry (hereafter, an "Entry"). By submitting an Entry, you are acknowledging and agreeing to these "Official Rules", including, without limitation, that Sponsor has the right to use your Entry as set forth in these Official Rules. All Lead Gen Form Entries must comply with LinkedIn's User Agreement available at <https://www.linkedin.com/legal/user-agreement>. 2) Online Entry Form: To enter without completing the LinkedIn Lead Gen Form, visit nyjets.com/suiteleadsweeps during the Promotion Period and follow the instructions provided to complete/submit the Official Entry Form to receive one (1) Entry.

All entries must be received by 11:59:59 pm ET on 8/17/25 to be eligible. Limit one (1) Entry per person, per email address and per household throughout the Promotion Period. You may only use one (1) email address or mobile phone number to enter the Sweepstakes. Entries received from any person, email address, or household in excess of the above stated limitation will be void. Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, email address, mobile phone number, address and other information for the purpose of administering this Sweepstakes and as otherwise set forth in Sponsor's Privacy Policy.
