

2026-27 PRE-PAID PARKING PERMIT DISCLAIMER

THIS PASS IS SUBJECT TO THE FOLLOWING CONDITIONS:

1. This is a revocable license to park one vehicle in one space on site at MetLife Stadium as directed by traffic/parking personnel. The license granted applies only to the specific event identified on this parking permit and only at the specific event time (the "Event"). The person seeking entry pursuant to this license agrees that failure to comply with any of these terms shall result in forfeiture of this license and all rights arising hereunder without refund and shall entitle the New York Jets and/or MetLife Stadium to pursue all legal remedies available.
2. Resale or attempted resale of this parking permit is prohibited, unless and only to the extent specifically authorized in writing by the New York Jets.
3. The stadium parking lot is specifically for use by patrons attending the Event. Patrons must have a valid Event ticket to enter MetLife Stadium.
4. The failure of any person to obey the instruction, direction or request of traffic/parking personnel or the violation of any of the New York Jets' and MetLife Stadium's rules, regulations, and/or policies, including without limitation any security and fan conduct policies and health and safety policies, may cause eviction from the parking lot and/or suspension or revocation of tickets and/or season tickets. 5. **ALL PERSONS USING THIS PERMIT, INCLUDING ALL GUESTS ARRIVING IN THE VEHICLE USING THIS PERMIT, VOLUNTARILY ASSUME ALL RISKS, HAZARDS AND DANGERS** while on the stadium parking lot, including liability arising from fire, theft, damage to, or loss of the vehicle or any article therein, the risk of personal injury (including death), the risk of exposure to communicable diseases, viruses, bacteria or illnesses or the causes thereof.
6. Any alteration or copying of this parking permit is prohibited. Use of this parking permit in violation of any law is strictly prohibited and will result in seizure, revocation and/or forfeiture of this permit without refund.
7. The one vehicle, one space policy will be strictly enforced. Violation of this rule may result in the expulsion from the parking lot and stadium and/or suspension or revocation of season tickets.
8. **ALL PARKING PERMIT SALES ARE FINAL. NO REFUNDS OR EXCHANGES EXCEPT AS PROVIDED HEREIN. THE SOLE AND EXCLUSIVE REMEDY** if admission is refused or revoked, or the event is cancelled and not replayed for any reason, is a refund of up to the face value of the license set by the New York Jets (the "Face Value"). Further, the New York Jets' and/or MetLife Stadium's liability for any breach of any terms applicable to this permit shall not exceed the Face Value.
9. Use of this permit by any person, including all guests arriving in the vehicle using this permit, constitutes a grant by all such persons and guests of irrevocable permission to the NFL, the New York Jets, and their respective sponsors, licensees, advertisers, broadcasters, designees, partners and agents to use, publish, distribute and/or modify such persons' and guests' image, likeness, voice, actions and statements in any medium for any purpose without further authorization or compensation, and a waiver of all claims and potential claims relating to such use except only to the extent prohibited by law.
