OFFICIAL RULES

If such modification or suspension occurs, Administrator will make a commercially reasonable effort to post notice of such modification or suspension.
56. **CHOICE OF LAW**: All issues and questions concerning the construction, validity, interpretation, and enforceability of these Rules, or the rights and obligations of an entrant and Administrator in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of Wisconsin, without giving effect to any choice of law or conflict of law rules (whether of the State of Wisconsin or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Wisconsin.
57. **DISPUTES**: All claims and disputes that arise out of or relate to the Promotion, these Rules interpretation or enforcement, or a winner's receipt or use of a prize ("Dispute") will be arbitrated under the Commercial Arbitration Rules of the American Arbitration Association ("AAA"), in English in Green Bay, Wisconsin before three neutral arbitrators who are members of the AAA. The arbitrators may award interim and final injunctive relief and other remedies, which may be confirmed or enforced in any court having jurisdiction. In the case of contradiction between the provisions of this Section and the Commercial Arbitration Rules of AAA, this Section will prevail. If any provision of this agreement to arbitrate is held invalid or unenforceable, it will be so held to the minimum extent required by law and all other provisions will remain valid and enforceable. Each party shall be responsible for their own costs and expenses issued in connection with the arbitration, suit or action, including attorney's fees and costs at the arbitration, suit or action and to enforce any arbitration award in court and on appeal. Without limiting the requirements in this Section, in any court proceedings or claims, the parties expressly agree to submit to the exclusive jurisdiction of the state and federal courts in Brown County, Wisconsin.
58. **LIST OF WINNERS**: To request the names of the winners, please send a self-addressed stamped envelope to the Promotion Address, Attn: Legal. Legal residents of the State of Vermont may omit return postage. Requests must be received within six (6) months of the end of the Promotion Period unless a longer time is expressly required by law. Unless prohibited by applicable law, Administrator reserves the right to deny such request.
59. **CONSTRUCTION OF RULES**: These Rules shall only be modified or amended in accordance with applicable law. In the event any section or provision of these Rules is held to be illegal, invalid, or unenforceable by any court, such holding shall not affect the validity of these Rules' remaining sections or provisions. The headings of the paragraphs in these Rules are for the convenience of reference only, and do not form a part hereof, and in no way define, limit, describe, modify, interpret or construe the meanings of Administrator, the scope of these Rules, or the intent of any paragraph hereof. Administrator's failure to enforce any term of these Rules shall not constitute a waiver of that provision. Administrator is not responsible for any electronic or typographical error in the posting, printing or reproduction of these Rules, administration of the Promotion, or in the announcement of prize winners.
