Official Rules

1. OVERVIEW/SWEEPSTAKES PERIOD

The **UScellular** 2022 "Ring in the Season Sweepstakes" (the "Sweepstakes") sponsored by UScellular ("Sponsor") at 12:01 a.m. Central Time ("CT") begins at 12:01 a.m. Central Time ("CT") on December 7, 2022 and ends at 11:59 p.m. CT on December 21, 2022 (the "Sweepstakes Period"). Administrator's (as defined in Rule 2, below) computer is the official timekeeping device for this Sweepstakes.

The Sweepstakes is subject to all applicable federal, state and local laws and regulations. 2. ELIGIBILITY

For your properly completed and submitted entry form, you will receive one (1) entry into the prize drawing described in Rule 4, below. Limit: One (1) entry per person per day during the Sweepstakes Period. Any attempt by any participant to obtain more than one (1) entry by using multiple/different email addresses, identities, registrations or logins, or any other methods will void that participant's entries and that participant may be disqualified from the Sweepstakes. 4. PRIZE DRAWING

On or around December 22, 2022, the Administrator will select one (1) potential winner in a random drawing from among all eligible entries received during the Sweepstakes Period. The odds of winning the prize depend on the number of eligible entries received during the Sweepstakes Period. The potential winner will be notified by phone or email using the information supplied on his/her entry form.

5. REQUIREMENTS OF POTENTIAL WINNER

The potential winner must meet all eligibility requirements set forth in these Official Rules and comply with these Official Rules to qualify for the prize. The prize winner may be required, at the discretion of the Sponsor, to complete, sign and return an Affidavit of Eligibility, Liability Release and, where permissible, Publicity Release within five (5) days of receipt of prize notification.
