

## St. Patrick's Day Sweepstakes Official Rules

**NO PURCHASE REQUIRED TO ENTER OR WIN.** Making a purchase will not increase your chances of winning.

This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook or Twitter. Facebook and Twitter are not affiliated with the Sponsor in any way.

**1. Eligibility:** The 2019 St. Patrick's Day Sweepstakes with U.S. Cellular (the "Sweepstakes") sponsored by U.S. Cellular ("Sponsor") is open only to legal residents of the fifty (50) United States and District of Columbia ("D.C.") who are 18 years of age or older at the time of entry (nineteen (19) or older if a resident of AL or NE). Employees of The Green Bay Packers ("Administrator"), Sponsor, the National Football League ("NFL"), its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC, and any of their respective subsidiaries, affiliates, authorized agents, sales representatives, distributors, advertising and promotional agencies, and members of the immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are NOT eligible to participate in this Sweepstakes. Non-eligibility or non-compliance with any of these Official Rules will result in disqualification. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void outside the 50 U.S./D.C. and where prohibited by law.

**2. Administrator:** The Sweepstakes is administered by the Green Bay Packers, 1265 Lombardi Avenue, Green Bay, WI.

**3. Agreement to Official Rules:** By participating in the Sweepstakes, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Administrator and Sponsor, which are final and binding in all matters related to the Sweepstakes.

**4. Promotion Period:** The Sweepstakes begins at 12:01 a.m. Central Time on March 1, 2019 and ends at 11:59 p.m. Central Time on March 14, 2019 (the "Promotion Period"). Administrator's computer is the official timekeeping device for this Sweepstakes.

**5. How to Enter:** During the Promotion Period, visit <http://www.packers.com/fan-zone/contests.html> (the "Website") and follow the links and instructions to complete and submit an entry form. You will receive one (1) entry into the Sweepstakes drawing described in Rule 6, below. **Limit: One (1) entry per person/household/email address per day during the Promotion Period.** Any attempt by any participant to obtain more than one entry per day by using multiple/different email addresses, postal addresses, identities, registrations or logins, or any other methods will void that participant's entries and that participant may be disqualified from the Sweepstakes. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by that entrant. In the event of a dispute as to the identity of any entrant, the authorized account holder of the email address associated with the entry will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof

of being the authorized account holder. All incomplete or non-conforming entries will be disqualified. Proof of submission of an entry does not constitute proof of receipt.

**6. Drawing:** On or about March 15, 2019, Administrator will select the winners of the prizes described in Rule 8, below, in a random drawing from among all eligible entries received during the Promotion Period. The potential winners will be notified by phone or email. The odds of winning a prize depend on the number of eligible entries received during the Promotion Period.

**7. Requirements of Potential Winners:** The potential prize winners must meet all eligibility requirements set forth in these Official Rules and comply with these Official Rules to qualify for a prize. The potential Grand Prize winner will be required to sign and return to Administrator, by March 22, 2019, at 5:00 p.m. Central Time, an Affidavit of Eligibility, Liability and Publicity Release (except where prohibited) in order to claim his/her prize and to fulfill any other requirements as determined by Administrator or Sponsor, or the prize will be forfeited. If the any prize/prize notification is returned as undeliverable, or a potential winner is deemed ineligible, that potential winner will be disqualified and will forfeit the prize.

In the event that a potential winner is disqualified for any reason, if time permits, Administrator will select an alternate potential winner in a random drawing from among all remaining eligible entries. If necessary, this process will be repeated up to three (3) times (time permitting). If the prize is not claimed by the third attempt to award it, the prize will not be awarded.

Five (5) Second Prize winners will receive their choice of one of the following styles of Packers St. Patrick's hats:

- One (1) "Tourist Cap" ARV: \$27.95 or
- One (1) "Murphy Cap" ARV: \$23.95

Total ARV of all prizes will depend on the Second Prize winners' choices of cap.

**All federal, state and local income taxes on the prizes are the responsibility of the winners.** Prizes cannot be transferred, assigned, redeemed for cash, sold, offered at auction, or substituted, in whole or in part, except at Sponsor's sole discretion or as provided herein. Sponsor may substitute a prize, or portion thereof, of equal or greater value if an advertised prize, or portion thereof, becomes unavailable for any reason.

The prizes consist only of the items described above. Use of the gift card is subject to all terms, conditions and policies of the issuer. Particular Bluetooth speaker awarded will be determined by Sponsor in its sole discretion.

**9. Publicity Consent:** Except where prohibited, participation in the Sweepstakes constitutes entrant's consent for Sponsor and Administrator and their respective designees to use entrant's name, likeness, voice, photo or other likeness and city/state of residence for purposes of advertising and trade, in commerce and in all media now known or hereafter discovered (including but not limited to the internet and social media), worldwide, without further notice, permission or compensation.

**10. General Conditions:** If for any reason the Sweepstakes is impaired and cannot be executed as planned, including but not limited to any printing, administrative, human or other error of any kind, transmission failure, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Sponsor and Administrator that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Sweepstakes, or if the Sweepstakes is compromised or becomes corrupted in any way, electronically or otherwise, Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules; or (b) terminate the Sweepstakes and award the prizes in a random drawing from among all eligible entries received up to the time of the impairment. In the event of termination, a notice will be posted on the Website.

The Sponsor reserves the right in its sole discretion to disqualify any individual it or the Administrator find to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

The Released Parties (as defined in Rule 11, below) are not responsible for: (a) electronic transmissions or entries that are lost, late, stolen, incomplete, illegible, damaged, garbled, destroyed, misdirected, or not received for any reason; (b) any problems or technical malfunctions, errors, omissions, interruptions, deletions, defects, delays in operation or transmission, communication failures or human error that may occur in the transmission, receipt or processing of entries, for deletion, theft or destruction of, unauthorized access to, or alteration of, entries; (c) failed or unavailable hardware, network or software; (d) causes beyond the Released Parties' reasonable control that jeopardize the administration, security, fairness, integrity or proper conduct of this Sweepstakes; (e) incorrect or inaccurate information whether caused by entrants or by any of the equipment or programming associated with or utilized in the Sweepstakes; (f) any typographical or other error in any printing or advertising relating to the Sweepstakes, in the administration or execution of the Sweepstakes, or in the announcement of the prize winners; or (g) cheating or fraud by any participant.

In the event that production, technical, seeding, programming or any other reasons cause more than five (5) prize notifications to be issued, the intended number of prizes will be awarded in a random drawing from among all legitimate prize claims received.

and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

**15. Participants' Privacy:** Any personally identifiable information collected in connection with an entrant's participation in this Sweepstakes will be used by Sponsor, its affiliates, agents and marketers only for purposes of the proper administration and fulfillment of the Sweepstakes, as described in these Official Rules, and in any manner consistent with Administrator's Privacy Policy, available on the Website.
