

## Official Rules

### **NO PURCHASE REQUIRED TO ENTER OR WIN**

**1. Eligibility:** The 2022 Packers 12 Days of Giveaways Sweepstakes (the "Sweepstakes") presented by ORORO is open only to legal residents of the fifty (50) United States who are 18 years of age or older at the time of entry. Employees of The Green Bay Packers, the NFL and any of their respective parent companies, subsidiaries, affiliates, agents and agencies that are involved in this Sweepstakes, and the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.

**4. Promotion Period:** The Sweepstakes begins at 12:01 a.m. Central Time December 13, 2022 and ends at 11:59 p.m. Central Time, December 24, 2022 (the "Promotion Period"). Administrator's computer is the official timekeeping device for this Sweepstakes.

**5. How to Enter:** During the Promotion Period, visit <http://www.packers.com/fan-zone/contests.html> and sign up for the sweepstakes by following the links and instructions to complete the registration. Complete and submit the registration. You then will receive 1 entry into the Sweepstakes. P.O. Boxes are not permitted, Limit: 1 Sweepstakes entry per day per duration of the contest. Any attempt by any participant to obtain more than one entry by using multiple/different email addresses, identities, registrations or logins, or any other methods will void that participant's entries and that participant may be disqualified from the Sweepstakes.
