

No Purchase Required to Enter or Win

1. Eligibility: Packers Everywhere Merch Monday ("Sweepstakes") is open to only legal residents of the 50 United States (except for New York, New Jersey, Rhode Island and Florida) who are 18 years of age or older at the time of entry. Employees of The Green Bay Packers, the NFL and any of their respective parent companies, subsidiaries, affiliates, agents and agencies that are involved in this Sweepstakes, and the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.

4. Promotion Period: The Merch Monday Sweepstakes begins around 2 p.m. Central Time on January 6, 2025 and ends at 2 p.m. Central Time, January 7, 2025 (the "Promotion Period"). Administrator's computer is the official timekeeping device for this Sweepstakes.

5. How to Enter: During the Promotion Period, potential entrant may enter the Sweepstakes by following the instruction in the relevant Call for Entries. The call for Entries will be made through social media channels of the Green Bay Packers. All entries received after the respective close dates of the Call for Entries will be void. Any use of robotic, automatic, programmed or similar entry methods or agents (including, but not limited to, Sweepstakes entry services) will void all entries by that entrant. In the event of a dispute as to any online entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

6. Requirements of Potential Winner: Potential winners must continue to comply with the Official Rules; and winning is contingent upon fulfilling all requirements.
