

No Purchase Required to Enter or Win

1. Eligibility: Packers Everywhere Win It Wednesday ("Sweepstakes") is open to only legal residents of the 50 United States (excluding NY, NJ & FL) who are 18 years of age or older at the time of entry. Employees of The Green Bay Packers, the NFL and any of their respective parent companies, subsidiaries, affiliates, agents and agencies that are involved in this Sweepstakes, and the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.
