- 5. How to Enter: During the Promotion Period, visit http://www.packers.com/fan-zone/contests.html (the "Website") and follow the links and instructions to complete and submit an entry form. You will receive one (1) entry into the Sweepstakes drawing described in Rule 6, below. Limit: One (1) entry per person/household/email address per day during the Promotion Period. Any attempt by any participant to obtain more than one entry per day by using multiple/different email addresses, postal addresses, identities, registrations or logins, or any other methods will void that participant's entries and that participant may be disqualified from the Sweepstakes. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by that entrant.
