

## 2018 Cardio Cats Experience Giveaway

### Official Rules

#### NO PURCHASE NECESSARY TO ENTER OR WIN.

**1) Eligibility:** The 2018 Cardio Cats Experience Giveaway (hereafter, "Sweepstakes") is open to legal permanent residents of the fifty (50) United States and District of Columbia who, prior to 6/7/18 are, (i) twenty-one (21) years of age or older; (ii) the named contact person on file (as determined by Sponsor in its sole discretion) of a Permanent Seat License (hereafter, "PSL") with the Carolina Panthers; and (iii) the recipient of the 2018 Cardio Cats Experience Giveaway email invitation sent by Sponsor (hereafter, "Eligible Entrants"). **2) Promotion Period:** Sweepstakes starts 10:00:00 am Eastern Time ("ET") on 6/7/18 and ends at 11:59:59 pm ET on 6/13/18 (hereafter, "Promotion Period").

**3) How to Enter:** During the Promotion Period, following receipt of the email invitation sent by Sponsor, Eligible Entrants will be directed to click on the link provided in the body of the email. Upon clicking the link, complete and submit the registration form to receive one (1) entry.

Entries must be received by 11:59:59 pm ET on 6/13/18 to be eligible. **Only one (1) entry per PSL account will be accepted throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. Sponsor reserves the right, in its sole discretion, to void any entries of entrants whom Sponsor believes have

Odds of winning a prize depends upon the total number of eligible entries received throughout the Promotion Period. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. Potential winners will be notified by telephone and/or email and may be required to execute and return an Affidavit of Eligibility, Liability and (where legal) Publicity Release within two (2) days of date of issuance of notification. Winners' guests Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

In the event the fitness class is postponed and rescheduled, winners will receive the prize experience for the rescheduled date.
