# Carolina Panthers 2022 Training Camp Helmet Walk Experience Official Sweepstakes Rules

Welcome to the Carolina Panthers 2022 Helmet Walk Experience Sweepstakes (the "Sweepstakes"), sponsored by Panthers Football, LLC ("Sponsor"). PLEASE READ THESE SWEEPSTAKES RULES CAREFULLY BEFORE USING ENTERING INTO THE SWEEPSTAKES.

THERE IS NO PURCHASE OR PAYMENT NECESSARY IN ORDER TO ENTER OR WIN THE SWEEPSTAKES. ANY PURCHASE OR PAYMENT OF ANY KIND THAT YOU MAKE WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS, AND IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

This Sweepstakes is accessible via Panthers.com at www.panthers.com/training-camp through a mobile device, or computer (collectively, the "**Platform**").

As a legal requirement for participating in this Sweepstakes as an entrant ("Entrant"), you ("You" or "Participant") hereby agree to be bound by these Sweepstakes Rules (the "Rules") which form a legal contract by and between You and Sponsor. If You do not agree and consent to these Rules, please do not enter the Sweepstakes or use the Platform.

#### 1. SWEEPSTAKES.

- 1.1 <u>Sweepstakes Description</u>. If an Entrant, Participant agrees to prepare and submit certain information ("Content") in accordance with the Rules as described herein. After submission, Entrant may or may not be deemed a winner, subject to eligibility and compliance with these Rules. Prizes will be awarded for this Sweepstakes, and will be publicly displayed on the Sweepstakes Landing Page.
- 1.2 <u>Sweepstakes Period.</u> Sweepstakes Start Date: 7/18/2022 9:00 AM EST. Sweepstakes End Date: 7/20/2022 5:00PM EST. The Sweepstakes will begin on the above Start Date, and will last through the above End Date ("Sweepstakes Period").
- 1.3 Rules. By participating in the Sweepstakes, Entrant unconditionally accepts and agrees to comply with and abide by these Rules, waives any right to claim ambiguity in the Rules or Sweepstakes related advertising/materials and agrees that the decisions of Sponsor with respect to the Sweepstakes and any prize awards shall be final and binding in all respects.

### 2. ELIGIBILITY.

Non-eligible Entities. Sponsor, and its parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies; and each of their respective officers, directors, employees, consultants and contractors (the "Sponsor Entities"), are ineligible to enter or vote on the Sweepstakes or win any related prize. ## Entrants.

Transportation to and from training camp will be the responsibility of the prize winner. Experience must be taken on dates designated by Sponsor or prize will be forfeited in its entirety (and Sponsor will have no further obligation to winner) and, at Sponsor's discretion, may be awarded to an alternate. In the event the event is postponed and rescheduled, the trip will be rescheduled. In the event the event is postponed and not rescheduled, no compensation or substitution for such portion of the prize will be provided; however, the remainder of prize package will be awarded, and Sponsor will have no further obligation to winner. Winner must comply with all venue rules and regulations. Failure to do so may result in forfeiture of such portion of the prize and removal from event. Released Parties reserve the right to remove or to deny attendance to winner and/or quest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the event. - **4.2** Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete and/or inaccurate entries are void. All entries must

- include a valid email address for the Entrant.
- **4.3** Entrant winners will be announced after successfully submitting the online entry form, and after the end of the Sweepstakes Period.

Participant hereby waives any claims that Participant may have or acquire against the Sponsor for libel, slander, invasion of privacy, copyright or trademark violation, moral rights, right of publicity, rights of privacy, or false light arising out of or in connection with the Sponsor's or anyone else's use of the Content. Participant agrees that this waiver of privacy rights and constitutes a valid consent to uses of any Personally Identifiable Information ("PII") as may be required under applicable data protection laws. - **11.1** any incorrect or inaccurate Entry information, or for any faulty or failed electronic data transmissions;
- any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes;
- any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, camera, computers or providers utilized in any aspect of the operation of the Sweepstakes;
