2018 Panthers Pantherized Vehicle Contest

Official Rules NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The Panthers Pantherized Vehicle Contest is only open to legal residents of North Carolina and South Carolina, who are at least eighteen (18) years of age or older (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of Panthers Football, LLC (hereafter, "Sponsor"), Panthers Stadium, LLC, the National Football League and its member professional football clubs, NFL Ventures, L.P., and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. 3) How to Enter: During any one (1) of the Entry Periods, visit panthers.com/fans/extrememachines ("Website") and follow the instructions provided to complete and submit a registration form inclusive of uploading a photo of your Pantherized vehicle to receive one (1) submission into the Contest (hereafter, "Submission"). For purposes of these Offiical Rules, a Pantherized vehicle is defined as a vehicle that exemplifies the spirit of the Carolina Panthers.

By submitting a Submission, entrant hereby warrants and represents that the Submission conforms to the following submission requirements (hereafter, "Submission Requirements"): Submissions must be the original work of the entrant, may not have been previously published, must not have won previous awards, must not be immoral, obscene, profane or not in keeping with Sponsor's image or in violation of these rules. In addition, Submissions cannot include any third party intellectual property, general property, likeness or imagery. Submission cannot defame or invade intellectual property rights of any person, living or deceased, or otherwise infringe upon any copyrighted, trademarked, or patented works or person's personal or proprietary rights. If a Submission contains any material or elements that are not owned by the entrant, and/or which are subject to the rights of third parties, the entrant is responsible for obtaining, prior to uploading the

Any Submission not meeting all Contest Submission Requirements stated herein will be void.

By submitting a Submission, entrant hereby (i) grants the Released Parties, without any limitation of any other rights granted herein, permission for the Submission to be posted on panthers.com, social media channels, and any other media platform as determined by Sponsor in its sole discretion; (ii) acknowledges and agrees that his/her Submission may be shared via social media by third parties; and (iii) agrees that Released Parties are not responsible for any unauthorized use of Submissions by third parties. Released Parties do not guarantee the posting of any Submission and may remove a posted Submission at any time.

By submitting a Submission, entrant acknowledges and agrees that Sponsor may obtain many Submissions under this Contest and that such Submissions may be similar or identical in theme, idea, format or other respects to others submitted under this Contest and/or other Contests staged and/or sponsored by the Sponsor, or to other ideas conceived by or provided to Sponsor and entrant waives any and all claims entrant may have had, may have, and/or may have in the future, that any Submission and/or other works accepted, reviewed and/or used by the Sponsor (or its designees) may be similar to her Submission. Except where prohibited by law, each entrant acknowledges and agrees that the Sponsor does not have now, nor shall it have in the future, any duty or liability, direct or indirect, vicarious, contributory, or otherwise, with respect to the infringement or protection of any copyright in and to entrant's Submission or any other right related thereto.

4) Judging: Based on the criteria outlined below, eac. Sponsor and its designees, whose decisions will be final and binding in all matters relating to this Contest, will judge each Submission based on the following criteria: 1) Level of Originality (50%), 2) Passion: does the Submission reveal your passion for the Carolina Panthers? (30%), and 3) Relevance (20%) (the "Judging Criteria"). In the event of a tie, such tied Submissions will be re-judged based on the following criteria: Creativity: 100%. At the conclusion of each Entry Period, the entrant who submitted the top scoring Submission will be named a Grand Prize winner for a total of eight (8) Grand Prize winners; the

entrant who submitted the second top scoring Submission will be named a First Prize winner for a total of eight (8) First Prize winners; and the entrant who submitted the third top scoring Submission will be named a Second Prize winner for a total of eight (8) Second Prize winners, as determined by Sponsor in its sole discretion (subject to verification of eligibility and compliance with the terms of these rules). Potential winners will be determined on or about the date indicated in the chart in Section 2 of these Official Rules and will be notified by telephone and/or email. Failure to do so may result in forfeiture of such portion(s) of the prize and removal from game.
