## Touchdown Dance Contest

## Abbreviated Rules:

Contest is open to legal residents of the U.S. who are 18 years of age or older to enter. Contest begins on 9/2/21 and ends 9/19/21. Void where prohibited. Visit www.panthers.com for Official Rules.

- 1. Contest Period. Contest begins on September 2, 2021 and ends on September 19, 2021.
- 2. **Eligibility.** The Contest is open to legal permanent residents of North Carolina and South Carolina, who, prior to the date of entry are eighteen (18) years of age or older.

Employees, officers, directors, agents and representatives Panthers Football, LLC dba Carolina Panthers (hereafter, "Sponsor"), the National Football League, its member professional football clubs, NFL Ventures, L.P., OrthoCarolina, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies(hereafter collectively, "Released Parties"), and their immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win.

Once recorded, log into your Twitter, Facebook or Instagram ("Social Media Platform") profile and post your recording to your Social Media Platform feed using the hashtag #TDContest and tagging @OrthoCarolina in the post (each an "Entry"). All Entries by entrants must comply with the applicable Social Media Platform's Terms of Service/Use. This Contest is in no way sponsored, endorsed or administered by, or associated with, Twitter, Facebook or Instagram.

Entrant may not enter more than once using multiple email addresses, identities, or devices in an attempt to circumvent the rules.

4. **Contest Requirements.** All Entries must comply with these Official Rules and the entry instructions in order to be eligible. In the event the Sponsor, in its sole discretion, determines that

The entrant with the highest overall score from all eligible Entries will be deemed the prize winner. In the case of a tie, the entrant with the highest score in the creativity category will be deemed the prize winner.

7. **Prizes.** One (1) prize winner will receive four (4) tickets to one (1) 2021 Season Carolina Panthers home game of winner's choosing (subject to availability). Location of tickets to be determined solely by Carolina Panthers

Limit one (1) prize per winner. Prizes are not transferable. No substitution or transfer of prize permitted except at the sole discretion of the Sponsor.
