NFL Draft Experience Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN ANY PRIZE. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- **1. Deadlines:** To be eligible for any prize, you must submit a valid entry between March 21, 2019 at 12:01 AM PST and March 29, 2019 at 11:59 PM PST.
- **2. Prizes:** From among all those who submit a valid entry (each an "Entrant"), one (1) prize winner will be selected at random to win the following ("NFL Draft Prize"):
 - a) Two (2) tickets to attend the 2019 NFL Draft in Nashville. Specific day of draft is in the Raiders discretion.
