

## **“Purple Ticket to Health” Sweepstakes Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY IN ORDER TO ENTER OR WIN THE SWEEPSTAKES. ANY PURCHASE OR PAYMENT OF ANY KIND THAT YOU MAKE WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS, AND IS VOID WHERE PROHIBITED BY LAW AND OUTSIDE THE UNITED STATES.**

In the “Purple Ticket to Health” (the “**Sweepstakes**”), the Baltimore Ravens (“**Sponsor**”), GEHA, Novo Nordisk, and MedStar Health have teamed up to provide the Flock with access to free diabetes screening as an initial step towards achieving a healthier lifestyle and the opportunity to enter into the Sweepstakes upon completion of the screening. By completing a short, 60-second online risk assessment via MedStar Health, you will have the chance to enter to win one of one hundred and forty-five (145) prizes, including a VIP gameday experience, autographed merchandise and exclusive, on-field and behind-the-scenes events at M&T Bank Stadium. A separate link to enter to the Sweepstakes will be provided upon completion of the risk assessment. The Sweepstakes is powered by Wit Labs, Inc. (“**Wit**” or “**Administrator**”) on behalf of Sponsor and is accessible via the Wit website at <https://web.witcontests.com/ravens/giveaway/scratchnwin/purple-ticket-to-health-220907> or through a mobile device or computer at [www.baltimoreravens.com/purpleticket](http://www.baltimoreravens.com/purpleticket) (the “**Website**”)(collectively, the “**Platform**”). For the avoidance of doubt, Wit provides the Platform for the Sweepstakes, but is not the sponsor for the Sweepstakes. GEHA, Novo Nordisk, and MedStar Health are related parties, but are not sponsors of the Sweepstakes (“**Related Parties**”) and are not responsible for its execution and/or any of the giveaways/prizes that may be part of the Sweepstakes. Protected health information provided to MedStar Health will NOT be shared with the Baltimore Ravens, GEHA, Novo Nordisk or any other team partners.

As a legal requirement for participating in this Sweepstakes as an entrant (“**Entrant**”), you (“**You**” or “**Participant**”) hereby agree to be bound by these Sweepstakes Official Rules (the “**Official Rules**” or “**Rules**”) which form a legal contract by and between You and Sponsor. **If You do not agree and consent to these Rules, please do not enter the Sweepstakes or use the Platform. By creating and using a Wit account, You are further required to read and agree to the Wit [Terms of Use](#).**

**1.ELIGIBILITY:** The Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older at the time of entry (each, an “**Eligible Entrant**,” or “**Entrant**,” or “**You**”). Employees, officers, and directors of Sponsor, Administrator, Related Parties, and each of their respective parents, subsidiaries, and affiliated companies, representatives, consultants, contractors, agents, divisions, dealers, distributors, legal counsel, advertising, public relations, promotional, fulfillment, and marketing, website and/or platform providers, web masters, and their respective officers, directors, employees, and administrative agencies; and anyone else connected with the production and distribution of this Sweepstakes (collectively “**Released Parties**”) and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and those living in their

same households, whether or not related to any of the above named entities are not eligible to participate or win. Unless You opt-in for future communication, the information You provide will only be used for Sweepstakes purposes.

**4. SWEEPSTAKES PERIOD:** The Sweepstakes begin on Saturday, August 27, 2022 at 9:00:01 a.m. Eastern Time (“ET”) and ends on Friday, January 27, 2023 at 11:59:59 p.m. ET (hereafter “Sweepstakes Period”).

**5. ENTRY:** There are three (3) ways to enter during the Sweepstakes Period (each, an “Entry”):

(1) **In-Person:** Visit the Purple Ticket to Health tent(s) at designated events offered by Sponsor, including outside home games, such as A Purple Evening on Monday, October 17, 2022, during the Sweepstakes Period. At the tent, you will be directed to the Platform to complete the 60-second Health Survey, then receive a separate link to enter the Sweepstakes;

(2) **Online:** Visit [baltimoreravens.com/purpleticket](http://baltimoreravens.com/purpleticket) using a computer or mobile device during the Sweepstakes Period and follow the instructions provided to complete the 60-second Health Survey and then receive the link to complete and submit the registration form to receive a single entry; OR

(3) **Mail-In:** Hand print your name, complete mailing address, telephone number, date of birth, email address and the words “Purple Ticket to Health” on a plain piece of paper and mail it in an envelope with proper postage affixed to: Purple Ticket to Health, 1 Winning Drive, Owings Mills, MD 21117.

**Online and Mail-In entries must be received by 11:59:59 p.m. ET on the date in Table 1 for the corresponding prize.**

**Limit of one (1) entry per person throughout the Sweepstakes Period, regardless of method of entry.** Additional entries received from the same person in excess of the stated limitation will be void. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of a false identity, script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor’s sole discretion and in accordance with these Official Rules) are void. In the event of a dispute as to the identity of Entrant based on the email address submitted, entry will be awarded to the person named on the applicable entry (regardless of whether that is the name of the authorized account holder of the email address from which said entry form was submitted), provided such individual is eligible according to these Official Rules.

**6. PRIZES:** A predetermined number of unique eligible Entrants will become Winners, who will receive predetermined prizes based on the Sponsor’s prize allocation structure, whose

decisions are final on all matters relating to this Sweepstakes. Over 100 prizes are available; please refer to Table 1 below for descriptions. The Approximate Retail Value (“ARV”) of each prize is between \$250 USD to \$594 USD. The total ARV of all prizes is \$32,620. All prize details are at Sponsor’s sole and absolute discretion.

the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, mail, or the announcement of the prize; or for any injury or damage to participant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials.
