OFFICIAL RULES FOR THE 2021 M&T BANK BALTIMORE RAVENS SCHEDULE CHALLENGE PROMOTION (THE "PROMOTION")

NO PURCHASE, ACCOUNT OPENING, LOAN APPLICATION, DEPOSIT OR PAYMENT IS NECESSARY TO ENTER OR WIN, NOR WILL IT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. THE PROMOTION IS GOVERNED BY THESE OFFICIAL RULES (THE "RULES"). BY PARTICIPATING, EACH ENTRANT AGREES TO ABIDE BY THESE RULES, INCLUDING THE ELIGIBILITY REQUIREMENTS, AND UNDERSTANDS THAT THE RESULTS, AS DETERMINED BY THE SPONSOR AND/OR THE ADMINISTRATOR, AND THEIR RESPECTIVE AGENTS, ARE FINAL IN ALL RESPECTS.

- 1.) **GENERAL RULES AND METHODS OF ENTRY:** This Promotion will begin at 9:00 a.m. ET on Thursday, April 1, 2021 and will end at 11:59 p.m. ET on Friday, April 30, 2021 (the "Promotion Period"). Despite the end of the Promotion Period, the 2021 Baltimore Ravens football schedule will not be finalized by the NFL until early to mid-May 2021. This schedule, as initially released by the NFL (the "Schedule") will form the basis of this Promotion; any subsequent schedule changes will have no effect on this Promotion. During the Promotion Period, there will be two methods for entrants ("Entrants") to enter. The following methods of entry are referred to herein as "Entry Methods":
 - A. Entrants may enter by logging onto BaltimoreRavens.com/schedulechallenge and completing the multiple-choice questionnaire, the contents of which are based on the Schedule (the "Questionnaire,") that is located on that website. When completing an entry via this online Entry Method, Entrants will be asked to provide their full name, mailing address, telephone number, and e-mail address (among other information).
 - B. Entrants may also enter by detaching the copy of the Questionnaire that is attached to these Rules as "Attachment A" and completing the Questionnaire by using black or blue ink, including completing the information listed on the top of the Questionnaire, then sending the completed Questionnaire in an envelope with proper postage to Baltimore Ravens, Attn: Schedule Challenge, One Winning Drive, Owings Mills, MD 21117. All Questionnaires completed using this mail-in Entry Method must be legible, complete and received prior to the end of the Promotion Period to be considered eligible. Only one Entrant name on each completed Questionnaire and one Questionnaire per envelope are allowed.

Except as described in Section 4 below, to be eligible for the below-described random drawings, Entrants must correctly answer the questions on the Questionnaire relating to the Schedule.

Neither Sponsor, Administrator, nor their respective officers, directors, shareholders, employees, contractors and/or agents are responsible for incorrect or inaccurate transcription of entry information. Entry materials that have been tampered with or altered are void. Sponsor and Administrator reserve the right, in their discretion, to cancel, modify, or suspend the Promotion should technical or other occurrences beyond the control of the Sponsor and/or Administrator compromise its administration, security, or proper play.
- 3.) **PRIZES:** Except as described below, 101 prizes (the "Prizes") will be awarded as part of the Promotion. Except as described below, there will be one grand prize (the "Grand Prize") which will be comprised of two tickets to an away game of the Baltimore Ravens choice (the "Game"), 2 round trip coach class air transportation tickets from Baltimore Washington International Thurgood Marshall Airport ("BWI") to an airport near the Game (in Administrator's sole discretion), 2 nights hotel accommodations (standard room, double occupancy) at a hotel of Administrator's choice near the destination. Total Approximate Retail Value ("ARV") of the Grand Prize is \$1,200. Except as described below, there will be 100 secondary prizes (each, a "Secondary Prize"), each of which will consist of one Official Baltimore Ravens 2021 Draft cap (ARV of all 100 Secondary Prizes is \$2,500). Prizes are awarded "as is" with no warranty or guarantee, either express or implied, by Sponsor. The

total ARV of all Prizes is \$3,700. All Prizes are non-transferrable, and the Sponsor and the Administrator reserve the right to substitute any Prize for one of comparable or greater value, whether in cash or otherwise, if a Prize is not awarded as described herein for any reason.

Air Travel Restrictions: Air travel is subject to Southwest Airlines® terms and conditions; certain restrictions may apply. 4.) DETERMINATION AND NOTIFICATION OF THE WINNERS OF THE PRIZES; ODDS OF WINNING:

Following the Promotion Period, all valid Entries (by both Entry Methods) will be reviewed to determine how many questions on the Questionnaire have been answered correctly. Questionnaires will be scored based on the initial Schedule release; any subsequent schedule changes will have no effect on this Promotion. For each question answered correctly on the Questionnaire, an Entrant will receive 1 point. All Entrants who answered all of the questions on the Questionnaire correctly (and therefore received a score of 10 points) will, at that point, be deemed to be "Potential Grand Prize Winners." On or about May 15, 2021 (depending on the date of the release of the Schedule), the Grand Prize winner will be selected by random drawing from among all Entries submitted by the Potential Grand Prize Winners. After the Grand Prize winner has been selected, the Entries for all Potential Grand Prize Winners who did not win a Grand Prize will then be entered in the drawings for the Secondary Prizes (and all of these Entrants will then be deemed to be "Potential Secondary Prize Winners"). binding arbitration in accordance with the Federal Arbitration Act ("FAA," Title 9 of the United States Code) under the auspices of the American Arbitration Association ("AAA"); (b) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (c) judgment upon such arbitration award may be entered in any court having jurisdiction.
