

Baltimore Ravens Walter Payton Man of the Year Helmet Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.

Void where prohibited or restricted by law, rule or regulation. This **Baltimore Ravens Walter Payton Man of the Year Helmet Sweepstakes** (the “Sweepstakes”) is subject to all applicable federal, state, local laws, rules and regulations. This Sweepstakes is sponsored and administered by the Baltimore Ravens Limited Partnership (the “Club”). **This promotion is in no way sponsored, endorsed, administered by, or associated with any social media platform.**

- 1. Eligibility:** This Sweepstakes is offered and open to persons who are legal residents of the fifty (50) United States and the District of Columbia and are eighteen (18) years of age or older as of the date of participation. Employees, officers, directors, agents and representatives of the Club, Nationwide Mutual Insurance Company, the National Football League, its member professional football clubs, and NFL Ventures, LLC, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, “Sweepstakes Releasees”), and each such individual’s immediate family members (husband, wife, mother, father, sister, brother, child, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. The Sweepstakes is subject to all applicable federal, state, and local laws. Void outside of the United States and where prohibited by law. - 2. Promotion Period:** Sweepstakes begins Friday, January 2, 2026 at 12:01 AM Eastern Time (“ET”) and ends on Saturday, January 3, 2026 at 11:59PM ET (hereinafter, “Promotion Period”). The Club’s computer is the official timekeeping device for this Sweepstakes.
- 3. To Participate:** During the Promotion Period, to enter and receive one (1) entry, all eligible Entrants must:
 - a.** Visit @Ravens on the social media platform “X” during the Promotion Period to find the applicable social media post; and
 - b.** Republish (*ie*, retweet, repost, etc.) the applicable social media post on the same social media platform using Entrant’s personal user account to vote for the Ravens’ nominee for the Walter Payton Man of the Year award;

To become a registered user of X, visit <https://x.com> and follow the onscreen instructions to sign up for an account. Becoming a registered user of X is free. Entries must be received by 11:59 PM on January 3, 2026 to be eligible to win. **Limit of one (1) entry per person throughout the Promotion Period regardless of method of entry for the duration of the Promotion Period. Additional entries received from the same natural person in excess of the stated limitation will be void. Anyone found to be using multiple accounts to enter the Sweepstakes, otherwise submitting multiple entries in violation of these Official Rules, or violating the social media platform’s terms of service will be deemed ineligible for the Sweepstakes, and all their entries may be deemed void.** All entries become the exclusive property of the Club and the Club has no obligation to acknowledge or return any entry. The use of a script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void. In the event of a dispute as to the identity of an Entrant based on the profile used for submission, the entry will be deemed to be submitted by the person named on the applicable entry (regardless of whether that is the name of the authorized account holder of the email address from which said entry form was submitted), provided such individual is eligible according to these Official Rules.

Total Estimated Retail Value of each Grand Prize is approximately \$450.00.

All Prizes are non-transferrable, and the Club and the Administrator reserve the right to substitute any Prize for one of comparable or greater value, whether in cash or otherwise, if a Prize cannot be awarded as described herein for any reason.
