

Baltimore Ravens Gameday Bingo Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.

Void where prohibited or restricted by law, rule or regulation. This Baltimore Ravens Gameday Bingo Sweepstakes (the "Sweepstakes") is subject to all applicable federal, state, local laws, rules and regulations. This Sweepstakes is sponsored and administered by the Baltimore Ravens Limited Partnership (the "Club").

- 1. Eligibility:** This Sweepstakes is offered and open to persons who are legal residents of All 50 States and District of Columbia and eighteen (18) years of age or older as of the date of participation. Employees, officers, directors, agents and representatives of the Club, Club, Co-Sponsor (if applicable, and as defined herein), the National Football League (the "NFL"), its member professional football clubs, and NFL Ventures, LLC, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (collectively, the "Sweepstakes Releasees"), and each such individual's immediate family members (husband, wife, mother, father, sister, brother, child, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. The Sweepstakes is subject to all applicable federal, state, and local laws. Void outside of the United States and where prohibited by law. Only an individual meeting all eligibility requirements set forth in these rules (the "Official Rules") may participate in the Sweepstakes or win a prize (the "Entrant"). In the event of any conflict or inconsistency with any other advertising, promotional or other materials, these Official Rules shall govern. The Club reserves the right to verify the eligibility of winner before awarding any prize.
- 2. Promotion Period:** Sweepstakes begins on Thursday, August 7, 2025 at 7:00PM Eastern Time ("ET") and ends at 11:59 PM on the date of the last football game in which the Baltimore Ravens football team participates during the 2025 NFL Season (including playoffs) (hereinafter, "Promotion Period"). The Club's computer is the official time keeping device for this Sweepstakes. The Promotion Period will be divided into separate entry periods (each, an "Entry Period"), with each Entry Period being held on the date of a Baltimore Ravens game played during the Bingo Period (each, a "Game") beginning at the official start of such Game and ending at the official end of such Game.
- 3. To Participate.** Prior to or during an Entry Period, Entrants must download the Application available on the Apple App Store and Google Play (the "Application") to their personal mobile device. Once the Application is downloaded to a personal device, Entrants must navigate to the promotional link to Ravens Bingo to participate. Once Entrant taps the "Ravens Bingo" button, a randomly generated electronic Bingo playing card (the "Bingo Board") for the applicable Entry Period will appear on the screen of the mobile device. During each Entry Period, any plays or other events that occur during the applicable Game will automatically check off on Entrant's Bingo Board as they occur on the playing field (each, a "Game Event"). Entrants are encouraged to hit "refresh" at any time to make sure they did not miss a Game Event. Entrants may participate in Bingo only via the Application using your mobile device or on your computer's web browser via <https://www.baltimoreravens.com/fans/gameday-bingo>. No other method of entry will be accepted. For the purposes of Bingo, multiple Entrants are not permitted to share the same account in the Application. Limit of one (1) Bingo Board per Entrant per Entry Period. Any attempt by an Entrant to use multiple accounts, identities, registrations and logins, or any other methods, will void that Entrant's entry and that Entrant may be disqualified from the Bingo in the Club's sole discretion. All entries become the exclusive property of the Club and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter Bingo is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Club's sole discretion and in accordance with these Official Rules) are void.

The Club is not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, damaged, illegible, inaccurate, postage due or undelivered entries or mail, or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP),

phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, mail, or the announcement of the prize; or for any injury or damage to Entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Club reserves the right, in its sole discretion, to void any entries of Entrants whom Club believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

4. Winning Events. There are three (3) ways to win: "Single Bingo", "Winning Letter" (a letter shape unique to each Entry Period), and "Blackout Bingo" (each, a "Winning Event").

- Single Bingo - Five (5) Game Events marked off in a row, column or diagonally.
- Winning Letter - Game Events marked off such that they form the designated winning letter shape (for this period, the designated Winning Letter will be the capitalized letter "R") across the entire Bingo game board. The Winning Letter will be designated in the Application before the applicable Entry Period.
- Blackout Bingo - All of the Game Events on the Bingo game board are marked off.

Upon a Winning Event, a Bingo button in the Application will begin to pulse and Entrants must tap on the button in order to submit your Bingo game board as a potential winning entry. ENTRANTS MUST HIT THE PULSING BUTTON ("SINGLE", "THE LETTER", AND "BLACKOUT") IN ORDER TO WIN.

For each Entry Period, the first fifty (50) Entrants to tap the pulsing button during such Entry Period for a "Single" Bingo will be potential Entry Period single winners and subject to verification of eligibility and compliance with these Official Rules, the potential Entry Period single winners will be declared the official Entry Period single winners (each, an "Entry Period Single Winner"); the first Entrant to hit the pulsing button during such Entry Period for a designated Winning Letter Bingo will be potential letter winner and subject to verification of eligibility and compliance with these Official Rules, the potential letter winner will be declared the official letter winner (each, a "letter winner"); and the first Entrant to hit the pulsing button during such Entry Period for a "Blackout" Bingo will be the potential blackout winner and, subject to verification of eligibility and compliance with these Official Rules, the potential blackout winner will be declared the official blackout winner (the "Blackout Winner").

5. Winner Notification. The Application will automatically notify the Entrants if such Entrant is a potential winner. Entrants must follow the instructions appearing in the Application prize notification to claim their Prize as directed and within the time frame noted in such prize notification. Unless noted otherwise in the prize notification, all Prizes must be claimed thirty (30) days following the day of the applicable Game. Each entrant is responsible for monitoring his/her Application for prize notification and receipt of other communications related to Bingo. If a potential Prize winner does not claim his/her Prize during the time frame noted in the prize notification or above, as applicable, that potential Prize winner forfeits his/her Prize. Upon request of the Club, the potential winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form. If a potential winner fails to comply with these Official Rules, that potential winner will be disqualified and Club, in its sole discretion, may select the individual to achieve the applicable Winning Event after the applicable cut-off number noted above an alternate potential winner (e.g., if a potential letter winner is disqualified, the second 2nd individual whose Bingo board results in a Game Event's Letter Winning Event may be selected as an alternate potential letter winner). Less than the number of Prizes noted below may be awarded for an Entry Period if and depending on the number of Winning Events that occur during an Entry Period. All prize details are at Club's sole and absolute discretion.

6. Prizes. Prizes will be awarded per Entry Period as set forth below (each, a "Prize" and collectively, the "Prizes"). The exact number of Entry Period Single Prizes, Winning Letter Prizes and Blackout Prizes

depends on whether Game Events happen and whether a randomly generated Bingo game board results in a Winning Event.

Entry Period Single Prizes: The first forty (40) Entry Period Single Winners will receive a promotional code redeemable for 20% off any total purchase from Fanatics (each, an "Entry Period Single Prize").¹

Winning Letter Prizes: Up to one (1) Winning Letter Prize will be awarded per Entry Period. Each Letter Winner will receive one autographed Baltimore Ravens player merchandise item to be announced before each Entry Period, (the "Winning Letter Prize"). Item and player's autograph subject to change. Club will determine final item to be autographed and player's autograph in its sole discretion. ARV of each Letter Prize: \$150.

Blackout Prize. Up to one (1) Blackout Prize will be awarded per Entry Period. Each Blackout Winner will receive one autographed Baltimore Ravens player merchandise item to be announced before each Entry Period, (the "Blackout Prize"). Item and player's autograph subject to change. Club will determine final item to be autographed and player's autograph in its sole discretion. ARV of each Letter Prize: \$150.

All potential Winning Event winners that have completed entry by 11:59 pm EST on the last day of the Bingo Period will be entered to win one (1) grand prize (a "Grand Prize") consisting of an authentic Ravens jersey autographed by a player (specific player to be determined by Club in its sole discretion). Grand Prize winner will be determined by the most points awarded for participation in the Sweepstakes throughout the 2025 Baltimore Ravens football season. ARV of the Grand Prize: \$300. Except as determined by Baltimore Ravens in its sole discretion, no substitution of Prize is offered, no transfer of Prize to a third party is permitted, and Prize may not be redeemed for cash value. Any difference between stated ARV of a Prize and actual value of such Prize will not be awarded. For the avoidance of doubt, the Baltimore Ravens reserve the right to substitute a Prize (or applicable portion of a Prize) with one of comparable or greater value, as determined by the Baltimore Ravens in their sole discretion.

- 7. Prize Restrictions:** No transfer, assignment, sale, duplication, cash redemption or substitution of prize (or portion of prize) is permitted, except by Club. Club reserves the right to substitute a prize (or applicable portion of prize) with one of comparable or greater value, as determined by Club. Club is not responsible for and will not replace lost or stolen prize or any component thereof. Non-compliance with these Official Rules may result in disqualification and, at Club's sole discretion, the awarding of prize to an alternate winner. Winner is solely responsible for any and all applicable fees, taxes and expenses associated with a prize that are not specifically listed herein.

Additional terms, restrictions, and exclusions may apply to game tickets or sideline passes; see front and back of game tickets for additional terms and exclusions. All game tickets are subject to verification and are void and will be rejected if not obtained through authorized, legitimate channels, or if any part of any game
