2022 Ravens High School Combine
Official Rules
No Purchase Necessary To Enter or Win.
Purchasing Will Not Increase Your Chances of Winning.
All Federal, State and Local laws and regulations apply.

- 1) Promotion Period: The combine will begin on Thursday, August 11, 2022 at 12:00 p.m. Eastern Time ("ET") and end on Sunday, January 29, 2022 at 7:00 p.m. ET.
- **2) To Participate:** Participants must be currently enrolled in high school and in good standing on their football team in the state of MD. The participants must be between the ages of 15-19 and complete a waiver by the date of the combine in order to participate.
- **3) Combine:** During each regular or post season Baltimore Ravens home game, two (2) high school teams selected by the Baltimore Ravens will compete during the pregame on the field at M&T Bank Stadium in a head-to-head team relay. Each high school team will select an Offensive Lineman or Defensive Lineman who flips a tire from the goal line to the 10-yard line. This player then tags in a Running Back who weaves through a series of agility poles, then sprints to the 40-yard line. After the Running Back tags in their next teammate (either a Linebacker or Defensive Back), the third player back pedals from the sideline to meet the Quarterback in the middle of the field. Once the Quarterback is tagged in, a Wide Receiver streaks from the 30-yard line into the end zone to catch a touchdown pass from the signal caller. The team must complete a touchdown to end the relay, even if it takes a few attempts. The relay will be timed and begins when the players are told to start and ends with a completed touchdown. All timing will be controlled by the Baltimore Ravens.
- **4) Winner Selection:** The fastest team in the head-to-head competition is the winner of that game. The team with the fastest time at the end of the season (out of every high school to participate throughout the NFL season) will be the grand prize winner. In an event of a tie, the two teams would compete head-to-head on a TBD date and location to determine the winner. The combine will be run by the Club in accordance with the combine rules. All decisions regarding gameplay of the combine shall be made by the Club in its sole discretion.
- **5)** One Grand (1) Prize: The grand prize winner will be awarded jerseys, made by Under Armour, for the entire football team (maximum of sixty (60) total). All prize details are at Club's sole and absolute discretion.
- 6) Miscellaneous: No transfer, assignment, cash redemption or substitution of prize (or portion of prize) is permitted, except by Club, which reserves the right to substitute a prize (or applicable portion of prize) with one of comparable or greater value, as determined by Club. Non-compliance with these Official Rules may result in disqualification and, at Club's sole discretion, the awarding of prize to an alternate winner. By participating, entrants agree to be bound by these Official Rules and the decisions of the Club, which are final and binding and agree that: 1.) the Club and its designees may use (unless prohibited by law) their name, voice, city/state of residence, photograph and/or likeness for advertising and/or trade and/or for any other purpose in any media or format now or hereafter known, worldwide in perpetuity, without further compensation, permission or notification, and 2.) the Club and its designees and assigns shall have no liability and will be held harmless for any liability, loss, injury or damage, including, without limitation, personal injury, death or damage to personal or real property, to entrant or any other person or entity due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of a prize or participation in this Combine. Club reserves the right, in its sole discretion, to modify, suspend or terminate this Combine (or any portion thereof) should virus, bugs, non-authorized human intervention or other causes, including but not limited to war or armed conflict (whether or not officially declared), labor controversy or threat thereof, and/or acts of God, corrupt or impair the administration, security, fairness or proper play of the Combine and, in the event of termination, at its discretion, select winner from among all eligible participants as of the date of the event requiring such termination. ANY ATTEMPT BY ANY PERSON TO UNDERMINE

THE LEGITIMATE OPERATION OF THE COMBINE MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, CLUB RESERVES THE RIGHT TO SEEK REMEDIES (INCLUDING ATTORNEYS' FEES) AND DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING CRIMINAL PROSECUTION. Club's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

**7) Governing Law:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Participants or the Club in connection with the Combine will be governed by and construed in accordance with the internal laws of the State of Maryland, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.
