

“Find the Flock” Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.

Void where prohibited or restricted by law, rule or regulation. This promotion is subject to all applicable federal, state, local laws, rules and regulations.

1) Eligibility: The “Find the Flock” promotion (the “Promotion”) is open to legal residents of the fifty (50) United States and the District of Columbia who are the older of 18 years of age or the age of majority in their jurisdiction of residence at the time of entry. Entrants will need access to mobile internet and a Qualified Device to enter the Promotion. A "Qualified Device" means (a) an Apple mobile device (iPhone 7 and newer) with an iOS 10.0 operating system or newer or (b) a mid to high tier Android device with Android 7.0 operating system or newer. Employees, officers and directors of the Baltimore Ravens Limited Partnership (the “Club”) and its parents, subsidiaries and affiliated companies, representatives, directors, officers, agents, divisions, dealers, affiliates, distributors, advertising and promotional agencies, employees and assigns, advertising, promotion and administrative agencies; and anyone else connected with the production and distribution of this Promotion and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related to any of the above-named entities, are not eligible to participate or win. Only an individual meeting all eligibility requirements set forth in these Official Rules may participate in the Promotion or win a prize. In the event of any conflict or inconsistency with any other advertising, promotional or other materials, these Official Rules shall govern. The Club reserves the right to verify the eligibility of winner before awarding any prize.

2) Promotion Period: Promotion begins on January 11, 2021 at 12 a.m. Eastern Time (“ET”) and ends on Saturday, January 15, 2021 at 5 p.m. ET (hereinafter, “Promotion Period”). The Promotion consists of an instant win game (“Instant Win Game”) and a second-chance sweepstakes (the “Sweepstakes”). The Club’s computer is the official time keeping device for this Promotion.

3) To Participate:

a) **Instant Win Game:** Visit a participating location of a Ravens’ Participating Sponsor (each, a “Participating Location”) during the Promotion Period, open the camera on your mobile device and scan the QR code provided. Once you scan the posted QR code, follow the instructions provided to play the Instant Win Game (a “Game Play”). After the Game Play, the entrant will receive notification on the screen as to whether he/she is a potential “Instant Winner”. Potential winners of the Instant Win Game will be provided directions for validation. b) **Sweepstakes:** Each participant in the Instant Win Game who is not a potential winner will automatically receive one entry into the Sweepstakes. Online entries must be received by Saturday, January 9, 2021 at 5 p.m. ET and Mail-In entries must be postmarked by January 7th, 2021 and received by January 9, 2021 to be eligible. **Limit of one (1) Game Play per person at a location of each Participating Sponsor throughout the Promotion Period for a total of six (6) entries throughout the Promotion Period regardless of method of entry.** Additional entries received from the same natural person in excess of the stated limitation will be void. The Club is not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, damaged, illegible, inaccurate, postage due or undelivered entries or mail, or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Promotion, including, without limitation, errors which may occur in connection with the administration of the Promotion, the processing of entries, mail, or the announcement of the prize; or for any injury or damage to participant's or any other person's computer relating to or resulting from participation in this Promotion, or for printing, typographical, human or other errors appearing in these Official Rules or other Promotion-related materials. Club reserves the right, in its sole discretion, to void any entries of entrants whom Club believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Promotion or is in violation of these Official Rules.

4) Drawing/Winning:

- a) Instant Win Game:** up to fifty (50) random, computer generated winning times, one for each prize listed below, will be generated throughout the Promotion Period, up to ten (10) number of winning times will be generated per day. 13) Governing Law: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of participants or the Promotion Released Parties in connection with this Promotion will be governed by and construed in accordance with the internal laws of the State of Maryland, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.
