#### "Find the Flock" Official Rules

# NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.

Void where prohibited or restricted by law, rule or regulation. This promotion is subject to all applicable federal, state, local laws, rules and regulations.

- **Eligibility:** The "Find the Flock" promotion (the "Promotion") is open to legal residents of the fifty 1) (50) United States and the District of Columbia who are the older of 18 years of age or the age of majority in their jurisdiction of residence at the time of entry. Entrants will need access to mobile internet and a Qualified Device to enter the Promotion. #### 3) To Participate:

- a) **Instant Win Game**: Visit a participating location of a Ravens' Participating Sponsor (each, a "Participating Location") during the Promotion Period, open the camera on your mobile device and scan the QR code provided. Once you scan the posted QR code, follow the instructions provided to play the Instant Win Game (a "Game Play"). After the Game Play, the entrant will receive notification on the screen as to whether he/she is a potential "Instant Winner".
