## THE LAY'S GOLDEN GROUNDS SWEEPSTAKES OFFICIAL RULES

## NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Lay's Golden Grounds Sweepstakes ("Sweepstakes") is sponsored by Frito-Lay, Inc. ("Sponsor"), 7701 Legacy Drive, Plano, Texas 75024 and is administered by Prize Logic, LLC, 25200 Telegraph Road, Suite 405, Southfield, MI 48033 ("Administrator").

- C. Total ARV: The total ARV of all available Prizes in this Sweepstakes is \$58,000.

- **E. General:** In no event will more than the stated number of Prizes be awarded. If, for any reason, more than the stated number of notifications are sent (or more claims are received), Sponsor reserves the right to award the intended number of Prizes through a random drawing from among all eligible Prize claims received. Limit of one (1) Prize per person. AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE. EXEMPLARY. CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
