Baltimore Ravens Touchdown for Teachers Contest Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.

Void where prohibited or restricted by law, rule or regulation. This Contest is subject to all applicable federal, state, local laws, rules and regulations.

- Eligibility: This Touchdown for Teachers Contest presented by M&T Bank. (the "Contest") is offered 1) and open for entry only by persons who meet all of the following criteria: (A) employed in the state of Maryland; Sussex County, Delaware; and York County, Pennsylvania, (B) directly involved in the instruction and education of students (including teachers, guidance counselors, and teacher's aides, but excluding school and district administrators), (C) twenty-one (21) years of age or older as of the date of participation, and (D) properly nominated by a Nominator (defined below) via the Rules herein. Employees, officers, directors, agents and representatives of the Baltimore Ravens Limited Partnership ("Ravens" or "Club"), M&T Bank., the National Football League, its member professional football clubs, and NFL Ventures, LLC, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (husband, wife, mother, father, sister, brother, child, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. The Contest is subject to all applicable federal, state, and local laws. Void outside of the United States, and where prohibited by law. - **2)** Entry Period: Contest begins on Friday, February 23, 2024 at 9:01AM. Eastern Time ("ET") and ends on Friday, April 5, 2024 at 11:59PM. ET (hereinafter, "Entry Period"). The Club's computer is the official time keeping device for this Contest.
- **To Participate:** During the Entry Period, the Sponsors will accept from legal residents of 3) Maryland, Delaware or Pennsylvania who are 18 years of age or older (herein, the "Nominators"), nominations of Eligible Educators (as defined below) who have demonstrated outstanding service to their school and community ("Nominations"). Nominators must log onto "www.BaltimoreRavens.com/teachers" and complete and submit the requested information on the form located on the Contest Entry Page. Nominations submitted (a) without all required information, (b) without using the designated nomination form, or (c) outside the Entry Period, will be disregarded. Nominators must draft an original answer to the following questions: (1) What makes the teacher and their impact on their students and community special?; (2) Why do you think this teacher is deserving of the M&T Bank Touchdown for Teachers award?; and (3) How has this teacher gone "above and beyond" for their students? Nominators will be asked to provide the full name, mailing address, telephone number, and e-mail address (among other information) for both themselves and their nominee. Limit one (1) registration form submission per person and per email address for the duration of the Entry Period. Additional registration forms received from any such person or email address after the first registration form received from that person or email address will be void. All entries become the exclusive property of the Sponsors and will not be acknowledged or returned. The use of a script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void. Registration form submissions will be accepted throughout the Entry Period, in accordance with the terms of these Official Rules. In the event of a dispute as to the identity of an entrant based on the email address submitted, the entry will be deemed to be submitted by the person named on the applicable entry (regardless of whether that is the name of the authorized account holder of the email address from which said entry form was submitted), provided such individual is eligible according to these Official Rules.

- **Winner Selection:** Based on the criteria outlined below, all eligible entries received during the Entry 4) Period will, on or about April 19, 2024, be evaluated by a panel consisting of employees of M&T, the Ravens, community members and school officials (the "Panel"), and, as a result of such evaluation, one (1) Grand Prize Winner and two (2) Runner-up Prize Winners (for a total of three (3) winners) will be determined (the Grand Prize Winner and the Runner-up Prize Winners are collectively referred to herein as the "Prize Winners"). The Panel will judge, and "score," each eligible entry by assigning a point value to each eligible entry for each of the following, respective criteria: (a) amount of involvement in the school and/or community (volunteering, coaching, etc.) (0-5 points); (b) degree to which the Eligible Educator is a positive impact on the school and/or community (0-5 points); (c) degree to which the Eligible Educator demonstrates a commitment to education and the school and/or community (0-5 points); and (d) the originality of the story (0-5 points). The eligible entry with the highest point total will be deemed a potential Grand Prize Winner and the eligible entries with the next highest point totals will be considered potential Runner-up Prize Winners. In the event of a tie or series of ties that, after the above-described initial judging/scoring occurs, prevents the determination of which eligible entries have the three highest scores (as described above, one with the highest score, then the two with the next highest scores), any eligible entries (with the tied scores) will, as needed, be re-judged/re-scored based on the following criteria: how each respective Eligible Educator is a positive influence on his/her students, community and/or school (0-20 points).

The approximate retail value ("ARV") of the Grand Prize is \$7,675. Each Runner-Up Prize consists of (a) a \$1,000 grant to the winning teacher's school where he or she is employed during the 2023-2024 school year, and (b) one (1) customized Ravens jersey. The ARV of each Runner-Up Prize is \$1,175. The Total ARV of all prizes is \$10,025. All Prize details are at Club's sole and absolute discretion. **Odds of winning a prize will be determined by the total number of eligible Submissions received during the Entry Period.**
