

## **DraftKings Social Giveaway Sweepstakes Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.**

Void where prohibited or restricted by law, rule or regulation. This DraftKings Social Giveaway (the "Sweepstakes") is subject to all applicable federal, state, local laws, rules and regulations. This Sweepstakes is sponsored and administered by the Baltimore Ravens Limited Partnership (the "Club"). **This promotion is in no way sponsored, endorsed, administered by, or associated with any social media platform.**

- 1. Eligibility:** This Sweepstakes is offered and open to persons who are legal residents of the fifty (50) United States and the District of Columbia and are eighteen (18) years of age or older as of the date of participation. Employees, officers, directors, agents and representatives of the Club, DraftKings, the National Football League, its member professional football clubs, and NFL Ventures, LLC, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Sweepstakes Releasees"), and each such individual's immediate family members (husband, wife, mother, father, sister, brother, child, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. The Sweepstakes is subject to all applicable federal, state, and local laws. Void outside of the United States and where prohibited by law. Only an individual meeting all eligibility requirements set forth in these rules (the "Official Rules") may participate in the Sweepstakes or win a prize (the "Entrant"). In the event of any conflict or inconsistency with any other advertising, promotional or other materials, these Official Rules shall govern. The Club reserves the right to verify the eligibility of winner before awarding any prize.
- 2. Promotion Period:** Sweepstakes begins November 25, 2025 at 9:15 AM Eastern Time ("ET") and ends on November 26, 2025 at 9:14 AM ET (hereinafter, "Promotion Period"). The Club's computer is the official timekeeping device for this Sweepstakes.
- 3. To Participate:** During the Promotion Period, to enter and receive one (1) entry, all eligible Entrants must:
  - a. Visit @Ravens on the social media platform X ("X") during the Promotion Period to find the applicable social media post;
  - b. Republish (*ie*, retweet, repost, etc.) the applicable social media post on the same social media platform using Entrant's personal user account;
  - c. Mention @Ravens in the applicable republished social media post; and
  - d. Follow @DKSportsbook on the applicable social media platform.

To become a registered user of [X], visit [X] and follow the onscreen instructions to sign up for an account. Becoming a registered user of [X] is free. Entries must be received by 9:14 AM on November 26, 2025. **Limit of one (1) entry per person throughout the Promotion Period regardless of method of entry for the duration of the Promotion Period. Additional entries received from the same natural person in excess of the stated limitation will be void. Anyone found to be using multiple accounts to enter the Sweepstakes, otherwise submitting multiple entries in violation of these Official Rules, or violating the social media platform's terms of service will be deemed ineligible for the Sweepstakes, and all their entries may be deemed void.** All entries become the exclusive property of the Club and the Club has no obligation to acknowledge or return any entry. - 4. Winning Events:** The Sweepstakes will consist of one randomized drawing ("Prize Drawing") on or about November 26, 2025, from among all eligible entries received during the Promotion Period. Total Estimated Retail Value of each Grand Prize is approximately \$350.00.

Prizes are awarded "as is" with no warranty or guarantee, either express or implied, by Club. All Prizes are non-transferrable, and the Club and the Administrator reserve the right to substitute any Prize for one of comparable or greater value, whether in cash or otherwise, if a Prize cannot be awarded as described herein for any reason. All Prize details are at Club's sole and absolute discretion. **Odds of winning a prize will be determined by the total number of eligible Submissions received during the Promotion Period.**

Club reserves the right to substitute a prize (or applicable portion of prize) with one of comparable or greater value, as determined by Club. Club is not responsible for and will not replace lost or stolen prize or any component thereof. Non-compliance with these Official Rules may result in disqualification and, at Club's sole

discretion, the awarding of prize to an alternate winner. Winner is solely responsible for any and all applicable fees, taxes and expenses associated with a prize that are not specifically listed herein.
