



2021 Marching Ravens Appearance Guidelines, Terms & Conditions

Guidelines

Completion of the online form is a request only and does not guarantee an appearance by Baltimore's Marching Ravens. The online request form must be filled out completely or it will not submit properly. Please be aware of the following as you request an appearance from the Marching Ravens.

- Requests will only be considered if they are received at least four (4) weeks prior to the scheduled event.
- The Marching Ravens are only available for appearances from **April through December** each season. Due to practice schedules, the Marching Ravens are not available for appearances on Wednesday nights.
- **There is a fee associated with all Marching Ravens appearances. An appearance fee will be determined based on the nature of the request.** Appearance fees do not include travel fees, and an additional fee for travel may be assessed if the event takes place outside of the general appearance area.

Please allow 5-10 business days to receive a written response or telephone call from the Ravens regarding your request.

Stipulations

The following stipulations are expected as part of a Marching Ravens appearance request:

- All publicity for the event that mentions an appearance by Baltimore's Marching Ravens must be approved by the Baltimore Ravens before use.
- All appearance fees must be paid one (1) week prior to the appearance date. Payment information will be included with an appearance invoice.
- Parking in close proximity to event location must be provided for Marching Ravens members.
- A safe, clean and secure indoor location must be provided for members change into uniforms and leave belongings.

Fan Health Promise

Requestor agrees, on behalf of the Requestor and anyone for whom the Requestor involves in the appearance, that the Requestor and each such individual will not attend the Event if they have tested positive for COVID-19 within 14 days prior to the Event, or, **unless they are fully vaccinated for COVID-19 (as defined by the CDC)**, any of the following is true on the Event date:

- Within the prior 14 days, they have been exposed to someone who has tested positive for COVID-19, or are subject to a federal or local travel or quarantine advisory due to COVID-19;
- Within the prior 48 hours, they have experienced symptoms of COVID-19 (e.g., fever of 100.4°F or higher, cough, shortness of breath or difficulty breathing, chills, repeated shaking, muscle pain/achiness, headache, sore throat, loss of taste or smell, nasal congestion, runny nose, vomiting, diarrhea, fatigue or any other symptoms identified by the CDC) (anyone who is fully vaccinated but experiences any of the above symptoms within 48 hours before the Event should nevertheless consult a healthcare provider and get tested for COVID-19 before attending).
