## Loteria Scavenger Hunt Sweepstakes Official Rules

## NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.

Void where prohibited or restricted by law, rule or regulation. This **Loteria Scavenger Hunt Sweepstakes** (the "Sweepstakes") is subject to all applicable federal, state, local laws, rules and regulations. This Sweepstakes is sponsored and administered by the Baltimore Ravens Limited Partnership (the "Club"). **This promotion is in no way sponsored, endorsed, administered by, or associated with any social media platform.** 

- 1) Eligibility: This Sweepstakes is offered and open to persons who are legal residents of the fifty (50) United States and the District of Columbia and are eighteen (18) years of age or older as of the date of participation. Employees, officers, directors, agents and representatives of the Club, the National Football League, its member professional football clubs, and NFL Ventures, LLC, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Sweepstakes Releasees"), and each such individual's immediate family members (husband, wife, mother, father, sister, brother, child, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. - **3) To Participate & Win:** During the Promotion Period, to participate in the Sweepstakes, all eligible Entrants must visit @Ravens on the social media platforms X, Instagram, and Facebook (individually a "Platform" and collectively, the "Platforms") during the Promotion Period to find the applicable social media post with a clue for the location of one (1) of five (5) hidden tickest ("Winning Tickets") in Baltimore City. The first five (5) Entrants to find a Winning Ticket location and submit his or her information following the instructions on that Winning Ticket will be named a prize winner (a "Prize Winner")

Entries must be received before the end of the Promotion Period to be eligible to win. Odds of winning a prize will depend upon the total number of Entrants participating in the search for a Winning Ticket. Each potential Prize Winner will be notified through the contact information provided to Club and may be required to complete, sign and return an Affidavit of Eligibility and Publicity/Liability Release prior to the receipt of the prize, or the prize may be forfeited and awarded to an alternate winner.
