

## **Loteria Scavenger Hunt Sweepstakes Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.**

Void where prohibited or restricted by law, rule or regulation. This **Loteria Scavenger Hunt Sweepstakes** (the “Sweepstakes”) is subject to all applicable federal, state, local laws, rules and regulations. This Sweepstakes is sponsored and administered by the Baltimore Ravens Limited Partnership (the “Club”). **This promotion is in no way sponsored, endorsed, administered by, or associated with any social media platform.**

- 1) Eligibility:** This Sweepstakes is offered and open to persons who are legal residents of the fifty (50) United States and the District of Columbia and are eighteen (18) years of age or older as of the date of participation. Employees, officers, directors, agents and representatives of the Club, the National Football League, its member professional football clubs, and NFL Ventures, LLC, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, “Sweepstakes Releasees”), and each such individual’s immediate family members (husband, wife, mother, father, sister, brother, child, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. The Sweepstakes is subject to all applicable federal, state, and local laws. Void outside of the United States and where prohibited by law. Only an individual meeting all eligibility requirements set forth in these rules (the “Official Rules”) may participate in the Sweepstakes or win a prize (the “Entrant”). In the event of any conflict or inconsistency with any other advertising, promotional or other materials, these Official Rules shall govern. The Club reserves the right to verify the eligibility of winner before awarding any prize.
- 2) Promotion Period:** Sweepstakes begins Monday, May 5, 2025 at 10:00 AM Eastern Time (“ET”) and ends on Monday, May 5, 2025 at 2:00 PM (hereinafter, “Promotion Period”). The Club’s computer is the official timekeeping device for this Sweepstakes.
- 3) To Participate & Win:** During the Promotion Period, to participate in the Sweepstakes, all eligible Entrants must visit @Ravens on the social media platforms X, Instagram, and Facebook (individually a “Platform” and collectively, the “Platforms”) during the Promotion Period to find the applicable social media post with a clue for the location of one (1) of five (5) hidden ticket (“Winning Tickets”) in Baltimore City. The first five (5) Entrants to find a Winning Ticket location and submit his or her information following the instructions on that Winning Ticket will be named a prize winner (a “Prize Winner”)

Entries must be received before the end of the Promotion Period to be eligible to win. Odds of winning a prize will depend upon the total number of Entrants participating in the search for a Winning Ticket. Each potential Prize Winner will be notified through the contact information provided to Club and may be required to complete, sign and return an Affidavit of Eligibility and Publicity/Liability Release prior to the receipt of the prize, or the prize may be forfeited and awarded to an alternate winner. If the Prize Winner cannot be contacted; is ineligible according to these Official Rules; fails to return the required documents within the specified time period; declines his/her prize for any reason whatsoever; does not reply to the Administrator within 7 days of notification of winning, does not claim the prize in a timely fashion, or otherwise fails to fully comply with these Official Rules; or if prize notification is returned as undeliverable, Prize Winner will forfeit his/her prize and the prize may be awarded to an alternate Prize Winner from among all remaining eligible entries received, in the Club’s sole discretion. The Club will select up to three (3) successive alternate Prize Winners, after which point the Club may discontinue the Sweepstakes and retain the prize, at Club’s sole discretion. If a Winning Ticket is not found by the end of the Promotion Period, then the Club, in its sole discretion, may extend the promotion period until the undiscovered Winning Ticket is found.

To become a registered user of each Platform, visit the respective Platform URL and follow the onscreen instructions to sign up for an account. Becoming a registered user of any of the Platforms is free. A Winning Ticket must be submitted by the Entrant by Monday, May 5, 2025 at 2:00 PM. **Limit of one (1) entry per person throughout the Promotion Period regardless of method of entry for the duration of the Promotion Period. Additional entries received from the same natural person in excess of the stated limitation will be void. Anyone found to be using multiple accounts to enter the Sweepstakes, otherwise submitting multiple entries in violation of these Official Rules or violating the social media platform's terms of service will be deemed ineligible for the Sweepstakes, and all their entries may be deemed void.** All entries become the exclusive property of the Club and the Club has no obligation to acknowledge or return any entry. The use of a script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void. Submissions will be accepted throughout the Promotion Period, in accordance with the terms of these Official Rules. In the event of a dispute as to the identity of an Entrant based on the profile used for submission, the entry will be deemed to be submitted by the person named on the applicable entry (regardless of whether that is the name of the authorized account holder of the email address from which said entry form was submitted), provided such individual is eligible according to these Official Rules.

The Sweepstakes Releasees are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, damaged, illegible, inaccurate, postage due or undelivered entries or mail, or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, mail, or the announcement of the prize; or for any injury or damage to Entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Each Grand Prize will consist of one (1) exclusive Los Baltimore Cuervos Shirt, Ravens Hat, Ravens Keychain, and Ravens clear bag. Total Estimated Retail Value of each Grand Prize is approximately \$50.00. Prizes are awarded "as is" with no warranty or guarantee, either express or implied, by Club. All Prizes are non-transferable, and the Club and the Administrator reserve the right to substitute any Prize for one of comparable or greater value, whether in cash or otherwise, if a Prize cannot be awarded as described herein for any reason. All Prize details are at Club's sole and absolute discretion. **Odds of winning a prize will be determined by the total number of eligible Entrants participating in the search for the Winning Tickets during the Promotion Period.**
- 5) Prize Restrictions:** No transfer, assignment, sale, duplication, cash redemption or substitution of prize (or portion of prize) is permitted, except by Club. Club reserves the right to substitute a prize (or applicable portion of prize) with one of comparable or greater value, as determined by Club. Club is not responsible for and will not replace lost or stolen prize or any component thereof. Non-compliance with these Official Rules may result in disqualification and, at Club's sole discretion, the awarding of prize to an alternate winner. Winner is solely responsible for any and all applicable fees, taxes and expenses associated with a prize that are not specifically listed herein.
- 6) Verification of Potential Winners:** ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY CLUB, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES. AN ENTRANT IS NOT A WINNER OF ANY

PRIZE UNLESS AND UNTIL ENTRANT'S ELIGIBILITY HAS BEEN VERIFIED AND ENTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE.

If you do not agree to these terms, you should not participate in the Sweepstakes.
- 8) **General Conditions:** Club reserves the right, in its sole discretion, to modify, suspend or terminate this Sweepstakes (or any portion thereof) at any time. **12) Governing Law:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of participants or the Sweepstakes Released Parties in connection with this Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Maryland, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.

**13) Privacy:** By entering the Sweepstakes, each Entrant agrees that his or her entry and any other personally identifiable information collected in connection with the Sweepstakes may be used by Club and/or its affiliates for administration of this Sweepstakes, including in connection with Prize fulfillment, in accordance with the Privacy Policy located at <https://www.baltimoreravens.com/privacy-policy>.
