WASHINGTON COMMANDERS CHARITABLE FOUNDATION GAME DAY RAFFLE OFFICIAL RULES

This contest is open only to legal residents of the United States eighteen (18) years of age or older by August 25, 2024. Void in New York, Florida, outside the United States, and where prohibited. Employees, raffle sellers, agents and representatives (and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related) of Washington Commanders Charitable Foundation, Inc. ("WCCF") are not eligible to enter or win. By participating, entrants agree to be bound by these Official Rules and the decisions of the judges and/or WCCF, which are binding and final on matters relating to this raffle. Raffle is subject to all applicable federal, state and local laws. The raffle will consist of a random drawing and one (1) winner.

TIMING: The raffle begins the Thursday prior to the start of the designated home or away game and ends during the middle of the fourth quarter of the designated home or away game (the "Promotion Period"). A random drawing to determine one (1) prize winner will be held at the end of the Promotion Period. Winning number will be posted on the 50/50 Raffle website. Winner will have seven (7) days to claim the raffle prize by contacting the phone number listed on all raffle tickets.

TO ENTER: To enter, visit the 50/50 raffle website or purchase a raffle ticket from a WCF representative at the following location during the Promotion Period: 1600 Ring Road, Landover, MD 20785. Entrants will have the option of purchasing via credit card only 20 tickets for \$20.00 total, 150 tickets for \$50.00 total, or 400 tickets for \$100.00 total.

RANDOM DRAWING: One (1) winner will be selected in a random drawing at the end of the Promotion Period from among all eligible entries received during the Promotion Period. Odds of winning depend on the number of eligible entries received. The drawing will be conducted by a WCCF representative. WCCF holds the right to disseminate the winner's name via the team's Twitter accounts, Facebook accounts, and any or all of WCCF's social media platforms. Winner need not be present at the drawing.

WINNER NOTIFICATION: Winning number will be posted on the 50/50 Raffle website. Winner will have seven (7) days to claim the raffle prize by contacting the phone number listed on all raffle tickets. Except where prohibited by law, entry constitutes permission to use winner's names, hometowns and likenesses for online posting, and/or any advertising and publicity without additional compensation. Both the entrant and entrant's guest(s), if applicable, (or, where the potential winner is a minor, his/her parent or legal guardian) may be required to complete, sign and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within thirty (30) days of issuance. If such documents are not returned within the specified period time period, a prize/prize notification is returned as undeliverable,

or if a winner is not in compliance with these Official Rules, the prize will be forfeited and, at WCCF's discretion and time permitting, an alternate winner selected. If a potential winner is eligible but considered a minor in his or her state of permanent residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian who will be required to execute and return the affidavit/release and all other required documents on winner/minor's behalf as well as comply with any other requirements imposed on winner set forth herein.

PRIZES: Amount of prize awarded will be dependent on the size of the proceeds collected during the "promotional period". Winner will receive 50% of the net proceeds during the "promotional period" in which their winning number is selected. Contestants are eligible to win one (1) time during the Promotion Period.

No more than the stated prizes will be awarded. All prizes legitimately claimed will be awarded. If a winner cannot accept prize as stated, prize will be forfeited and, at Sponsor's discretion, an alternate winner selected.

Released Parties are not responsible for injury or damage to participants' or any person's computer related to or resulting from participating in this raffle. Persons who tamper with or abuse any aspect of the raffle, act in an unsportsmanlike or disruptive manner, or who are in violation of these Official Rules, as solely determined by WCCF, will be disqualified and all associated entries will be void. WCCF reserves the right at its sole discretion to suspend or modify the raffle should any portion of the raffle be, in WCCF's sole opinion, compromised by non-authorized human intervention or other causes which, in the sole opinion of the WCCF, corrupt or impair the administration, security, fairness or proper play, or submission of entries, or for any other reason determined by WCCF in its sole discretion and, if terminated, at its discretion, select the potential winner(s) for the drawing(s) at issue from all eligible, non-suspect entries received for the applicable drawing prior to action taken or as otherwise deemed fair and appropriate by WCCF. WCCF is not

responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's e-mail account to receive e-mail messages. WCCF is not responsible, and may disqualify an entrant, if his or her e-mail address, telephone, or other contact information does not work or if it is changed without entrant giving prior written notice to WCCF. WCCF's failure to or decision not to enforce any provision in these official rules will not constitute a waiver of that or any other provision. In the event there is an alleged or actual ambiguity, discrepancy or inconsistency between disclosures or other statements contained in any raffle-related materials and/or these official rules (including any alleged discrepancy or inconsistency in these official rules), it will be resolved in WCCF's sole discretion. The invalidity or unenforceability of any provision of these official rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these official rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. If WCCF determines at any time in its sole discretion that the winner or potential winner is disqualified, ineligible, or in violation of these official rules, WCCF reserves the right in its sole discretion to select an alternate winner, even if the disqualified potential winner's name may have been shown or announced publicly. If any person supplies false information, obtains entries by fraudulent means or is otherwise determined to be in violation of these official rules in an attempt to obtain any prize, WCCF may disqualify that person and seek damages from him or her and that person may be prosecuted to the full extent of the law.
