Odds of winning this prize depends on whether or not the Seattle Seahawks score six (6) touchdowns in a single Regular Season game and the number of eligible entries received for each Drawing.

Payment of any and all taxes, or other charges associated with the Groceries for Life prize, is the sole responsibility of the prize winner.

Special conditions of the Groceries for Life prize:

Odds of winning this prize depends on whether or not the Seattle Seahawks score five (5) touchdowns in a single Regular Season game and the number of eligible entries received for each Drawing.

**IF** the Seattle Seahawks score four (4) touchdowns in a single Regular Season game, the one (1) randomly selected individual, selected through the random Drawing of entries received and discussed above, will receive a Groceries for a Year prize, subject to verification. If the Seattle Seahawks do **not** score four (4) touchdowns in a single Regular Season game, there will be no Groceries for a Year prize awarded. Odds of winning this prize depends on whether or not the Seattle Seahawks score four (4) touchdowns in a single Regular Season game and the number of eligible entries received for each Drawing.

Payment of any and all taxes, or other charges associated with the Groceries for a Year prize, is the sole responsibility of the prize winner.

Special conditions of the Groceries for a Year prize:

The Groceries for a Year prize consists of \$5,200 in Albertsons, Safeway or Carrs Gift Cards.

## 5.1 PRIZES OF GROCERIES FOR A YEAR
