

Auto Renewal Terms and Conditions

LICENSEE RIGHTS AND OBLIGATIONS.

Automatic Renewal. By entering into this Agreement, Licensee hereby authorizes Tennessee Football, LLC (TFL) to charge Licensee's credit card (or withdraw from Licensee's bank account via Electronic Funds Transfer, if so selected by Licensee) for Licensee's annual Tennessee Titans Season Tickets and Licensee agrees to the terms and conditions listed herein. Licensee understands that Licensee has chosen from the following three payment options: (1) 12-month plan starting from September 1, 2026 – August 1, 2027 (the "12-Month Plan"); (2) two-installment plan on November 1, 2026 and May 1, 2027 (the "Two-Installment Plan"); and (3) Pay-in-Full option on February 1, 2027 (the "Pay-in-Full Option"). Each of the 12-Month Plan, the Two-Installment Plan, and the Pay-in-Full Option are each a "Payment Plan" and collectively the "Payment Plans". Based on the Payment Plan chosen by Licensee, Licensee also understands that any subsequent installment charges will be made to Licensee's authorized card/account in association to the 2027 football season (and each subsequent football season) in equal installments from September to August each year until Licensee's annual dues are paid in full. Licensee also understands that if Licensee chooses the 12-Month Payment Plan after February 1st of a given year, Licensee's required payments will be distributed equally across the remaining months of the 12-month term. **Licensee expressly acknowledges and agrees that Licensee's Tennessee Titans Season Tickets will automatically renew for each subsequent year following the 2027 football season on a date to be determined by TFL and Licensee's credit card (or Licensee's bank account via Electronic Funds Transfer, if so selected by Licensee) will be charged on the dates of the Payment Plan chosen by Licensee as described above for the corresponding renewal football season, unless either Licensee or TFL provides written notice of cancellation prior to such date.** TFL or Team will provide reasonable advance written or electronic notice (no less than 30 days) of the date on which Licensee's credit card will be charged (or funds withdrawn, if selected by Licensee) for Tennessee Titans season tickets for the first charge of each subsequent, new football season. **Licensee may opt-out of automatic renewal of Tennessee Titans Season Tickets throughout the year for any reason by providing TFL thirty (30) days written notice** by either (a) U.S. mail, certified return receipt requested addressed to Tennessee Titans, ATTN: Tennessee Titans Ticket Office, 460 Great Circle Rd, Nashville, TN 37228, or (b) via email to tickets@titans.nfl.com. Upon cancellation of participation in automatic renewal, Licensee shall not be entitled to any refund for installment payments made prior to such termination, and Licensee shall remain obligated to purchase Tennessee Titans Seasons Tickets in each year by the payment deadline imposed by the Team for such year in accordance with the terms of this Agreement and will be eligible for price increases for the remaining seasons pursuant to the Personal Seat License Agreement (the "PSL Agreement"). Licensee acknowledges and agrees that, unless otherwise cancelled, the foregoing payment authorization shall remain in effect for so long as this Agreement remains in effect. Licensee understands that the Team reserves the right, upon written notification, to modify Licensee's Payment Plan, including pricing, for future seasons and/or terminate this Agreement in accordance with the terms. Licensee also acknowledges and agrees that Licensee's PSL Agreement is subject to termination if Licensee does not stay in compliance with Licensee's payments for Tennessee Titans season tickets under this Agreement.
