

The Nissan Rise and Drive Giveaway

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

Eligibility: The Nissan Rise and Drive Giveaway ("Giveaway") is open to legal residents of Tennessee who are eighteen (18) years of age or older as of date of entry. Employees, officers & directors of Tennessee Football, Inc., doing business as the Tennessee Titans ("Sponsor"), Nissan North America, Inc. - **Entry Method #2:** Participants may also enter the Giveaway by visiting the Tennessee Titans Pro Shop located at Nissan Stadium, 1 Titans Way, Nashville, Tennessee 37213 between September 21, 2021 10:00 AM CT and September 24, 2021, 5:00PM CT and submitting a 3 x 5 notecard with their name, address, age, zip code, daytime and evening phone numbers, and email address (a "Submission" and/or "Entry").

Submitting an Entry constitutes your unconditional acceptance to these Official Rules.

Additional Entry Restrictions: By submitting an Entry, entrant hereby warrants and represents that the Entry conforms to the Entry Requirements set forth herein. Entries that are deemed to be immoral, obscene, profane or not in keeping with Sponsor's image or in violation of these Official Rules will be void.
