Eligible persons who play the Game are referred to in these Terms and Conditions as "you" or "Players."

**Name and Principal Address of Sponsor**. Tennessee Football, Inc., Saint Thomas Sports Park, 460 Great Circle Rd., Nashville, TN 37228.

**Eligibility**. The Game is offered and open to persons who (1) are legal residents of the United States (and who are not Excluded U.S. Residents, as further described below), (2) are eighteen (18) years of age or older as of the time and date of entry and (3) have a valid email address at the time and date of entry, except for any employees (full-time or part-time), officers and/or directors of the Tennessee Football, Inc. ("Sponsor" or "Titans"), the National Football League, its member professional football clubs, NFL Ventures, L.P., Xperiel, Inc., and FanDuel, Inc. ("FanDuel") and the family members of such employees, officers and/or directors. For purposes of this paragraph, "family members" shall mean the spouse, parents or children of such employees. Additionally, (1) residents of the State of Florida and the State of New York, and self-excluded persons in New Jersey are not eligible to participate in this Game ("Excluded U.S. Residents") and (2) in order to win a prize provided by FanDuel, Players residing in (a) the State of Massachusetts must be twenty-one (21) years of age or older and (b) the State of Alabama must be nineteen (19) years of age or older (collectively, "Excluded Fan Duel Prize Recipients"), in each case, at the time of awarding the prize, as further described below in the section entitled "Winner Selection/Notification."

The Game will run from the date and time that the Game is launched and available in the App until the last Titans game during the 2019 NFL Season ("Promotion Period") and incorporate thirteen (13) Titans regular season games and playoff games (if applicable). The Titans games during the 2019 NFL regular season for this Game are scheduled to take place on the following dates: 9/29/19, 10/6/19, 10/13/19, 10/20/19, 10/27/19, 11/3/19, 11/10/19, 11/24/19, 12/1/19, 12/8/19, 12/15/19, 12/22/19 and 12/29/19. Each game is scheduled to begin at the official starting time published on NFL.com (posted approximately ten (10) days in advance of each game date) and end no later than five hours thereafter. Official time will be kept by Sponsor.

### How to Get Started:

(1) During the Promotion Period, open the App and click on the "Titans Pick 'Em" button ("Game Button"). If you do not have the App, you can download it for free on the iOS and Android operating systems. After clicking the Game Button, you will need to confirm that you are eighteen (18) years of age or older and, if a first time user, complete the registration form to play the Game. Players are responsible for ensuring that all required information is accurate. Limit of one (1) registration form submission per person and per email address for the duration of the Promotion Period (each, a "Contest Entry"). Additional registration forms received from any such person or email address after the first registration form received from that person or email address will be void.

The use of a script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void. Registration form submissions will be accepted throughout the Promotion Period, in accordance with the terms of these Terms and Conditions. Contest Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Contest Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Terms and Conditions may be disqualified from the Contest in the Sponsor's sole and absolute discretion. Contest Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. All materials submitted become the physical property of the Sponsor and will not be returned. In the event of a dispute over the identity of an entrant, Contest Entries will be deemed submitted by the registered account holder of the email address associated with the entry for the domain associated with the submitted address provided that person is eligible. Winner(s) may be required to show proof of being the registered account holder. Registered account holder is defined as the person assigned to an email address by an Internet access provider, on-line service provider or other organization responsible for assigning email addresses. In the event a dispute regarding the identity of the individual who actually submitted a Contest Entry cannot be resolved to Sponsor's satisfaction, the affected Contest Entry shall be deemed ineligible. (2) After completion of the registration process, you will be given access to the "Titans Pick 'Em" home page ("Game Home Page") within the App. Visit the Game Home Page and follow the instructions.

### How to Play the Game:

<u>Object of the Game</u>. The object of the Game is to earn as many points as possible during the week of a Titans game (a "Game Week"). A Game Week will begin when the prior Titans game ends and end at the conclusion of the following Titans game. For example, the first Game Week for the 2019 NFL season shall begin when the Game is launched and available in the App and end upon the conclusion of the Titans vs. Atlanta Falcons

game on Sunday, September 29, 2019. There will be prizes awarded to the entrants with the most points each Game Week, along with Grand Prizes at the end of the 2019 Titans season, as further described in the "Prizes" section below.

How to Earn Points. Players may earn points in the Game in the following ways:

- (1) <u>Daily Questions</u>. Throughout each Game Week, one or more questions will be available for answering within the Game for a period of approximately twenty-four (24) hours. Such questions will relate to the upcoming Titans game and have a binary answer (e.g., "Yes" or "No") (e.g., "Will the Titans block a kick or punt?"). Players who answer such questions correctly will receive the number of points assigned to such correct answer at the time the question is answered (e.g., "Yes" 50 points; "No" 50 points).
- (2) <u>Weekly Questions</u>. Throughout each Game Week, one or more questions will be available for answering within the Game up to the time of kickoff for the Titans game. Such questions will relate to the upcoming Titans game and have a binary answer (e.g., "Yes" or "No") (e.g., "Will the opening kickoff result in a touchback?"). Players who answer such questions correctly will receive the number of points assigned to such correct answer at the time the question is answered (e.g., "Yes" 50 points; "No" 50 points).
- (3) <u>Predictions Each Drive</u>. During each Titans game, predict the outcome of offensive possessions by either team that begins from scrimmage (i.e., not including an offensive play that commences as the result of a turnover or receipt of a kickoff or punt). Such predictions shall be required to be made prior to the conclusion of the first play of each offensive possession, as determined by Sponsor. Once submitted, all predictions are final and cannot be modified for any play in progress or already completed. Correct predictions will result in the following number of points:

- (4) <u>Mini-Games In-between Drives</u>. During each Titans game, in-between drives, Players will have the opportunity to play three (3) different "mini-games": Words; Memory; and Trivia. The details of each mini-game are as follows:
  - a. *Words.* The Game will display a photo and a certain set of letters. Players will have 2 minutes to type out word combinations until they select the correct word. Maximum of 120 points may be earned for each correct answer, with the number of points decreasing by 1 point for each second that it takes for the Player to type in the correct answer. Words may be played up to 3 times per Titans game.
  - b. *Memory*. The Game will display 20 image cards faced down in a grid. Players will have 2 minutes to flip over the cards and attempt to select matching sets. If the

Player correctly matches the whole grid, the Player will receive points. Maximum of 120 points may be earned, with the number of points decreasing by 1 point for each second that it takes for the Player to correctly match all sets. Memory may be played up to 3 times per Titans game.

c. *Trivia.* The Game will pose a different trivia question each time this mini-game is selected. Players will have 10 seconds to answer the question. If the Player answers the question correctly, the Player will receive the number of points assigned to the question, which will depend on the difficulty level assigned to the question. Easy questions are worth 10 points; Medium questions are worth 20 points; and Hard questions are worth 30 points. Maximum of 10 Trivia questions may be answered each Game Week.

<u>Power Ups</u>. Players may amplify their points by earning and using "Power Ups." There are two types of Power Ups: Active Power Ups and Automatic Point Multipliers.

(1) <u>Active Power Ups</u>. To earn Active Power Ups, you have to perform a certain task. Upon earning an Active Power Up, you will have the option of applying the Active Power Up to one of your predictions in the Game. If you correctly make the prediction that has the Active Power Up applied, the number of points that you earn for the correct prediction will be multiplied by the number corresponding to the Active Power Up, as outlined in the following table:

(2) <u>Automatic Point Multipliers</u>. The Automatic Point Multiplier form of Power Up is earned and automatically applied to certain predictions, as outlined in the following table:

Additional Terms and Conditions.

- (1) Power Ups are optional and not required for participation. Each Power Up may be used only when offered in the Game and once used, it will disappear. There is no guarantee regarding the number of Power Ups that you will receive.
- (2) All predictions must be accepted and acknowledged by the computer servers by the applicable deadline (as determined by Sponsor) to be considered valid, timely, and eligible.
- (3) The total number of points at the end of one Game Week will not carry forward to the next Game Week. Each Player that plays the Game will start each Game Week with zero (0) points in the Game for such Game Week.
- (4) In the event of a Titans game postponement or cancellation, corresponding Game entries will be deemed cancelled and that portion of the Game will be null and void.
